### **The Northumberland County Council**

#### **Definitive Map Modification Order (No 2) 2024**

##### **Restricted Byway No 29 (Parish of Blanchland)**

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(ii) and (iii), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description; and that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 January 2024.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 2) 2024.

#### **Description of Modification to Definitive Map and Statement**

##### **Former Tynedale District**

<b>Blanchland</b>	<b>Restricted Byway / Footpath No 29</b>	<b>(NY 95 SW / SE)</b>
Part I	Map:	Upgrading thereto to restricted byway status, existing Public Footpath No 29, from a point marked C, on Byway Open to All Traffic No 80 in the Parish of Hexhamshire, at the south-west corner of Sleafy Forest, in a south-easterly direction for a distance of 1210 metres, to a point marked D, on Byway Open to All Traffic No 26, 1025 metres north of Pennypie House.
Part II	Statement:	To be amended as follows: A 5 metre wide restricted byway, from Byway Open to All Traffic No 80 in the Parish of Hexhamshire, at the south-west corner of Sleafy Forest, in a south-easterly direction for a distance of 1210 metres, to join Byway Open to All Traffic No 26, 1025 metres north of Pennypie House.

<b>Hexhamshire</b>	<b>Byway Open to All Traffic No 80</b>	<b>(NY 95 SW)</b>
Part I	Map:	The Map is not affected.
Part II	Statement:	To be amended as follows: From Byway Open to All Traffic No 78 at the Hexhamshire Parish boundary, west of Dukesfield Fell, in an easterly then south-easterly direction for a total distance of 1100 metres, to join Restricted Byway No 29 in the Parish of Blanchland, 200 metres north-west of Clerk's Quarry.

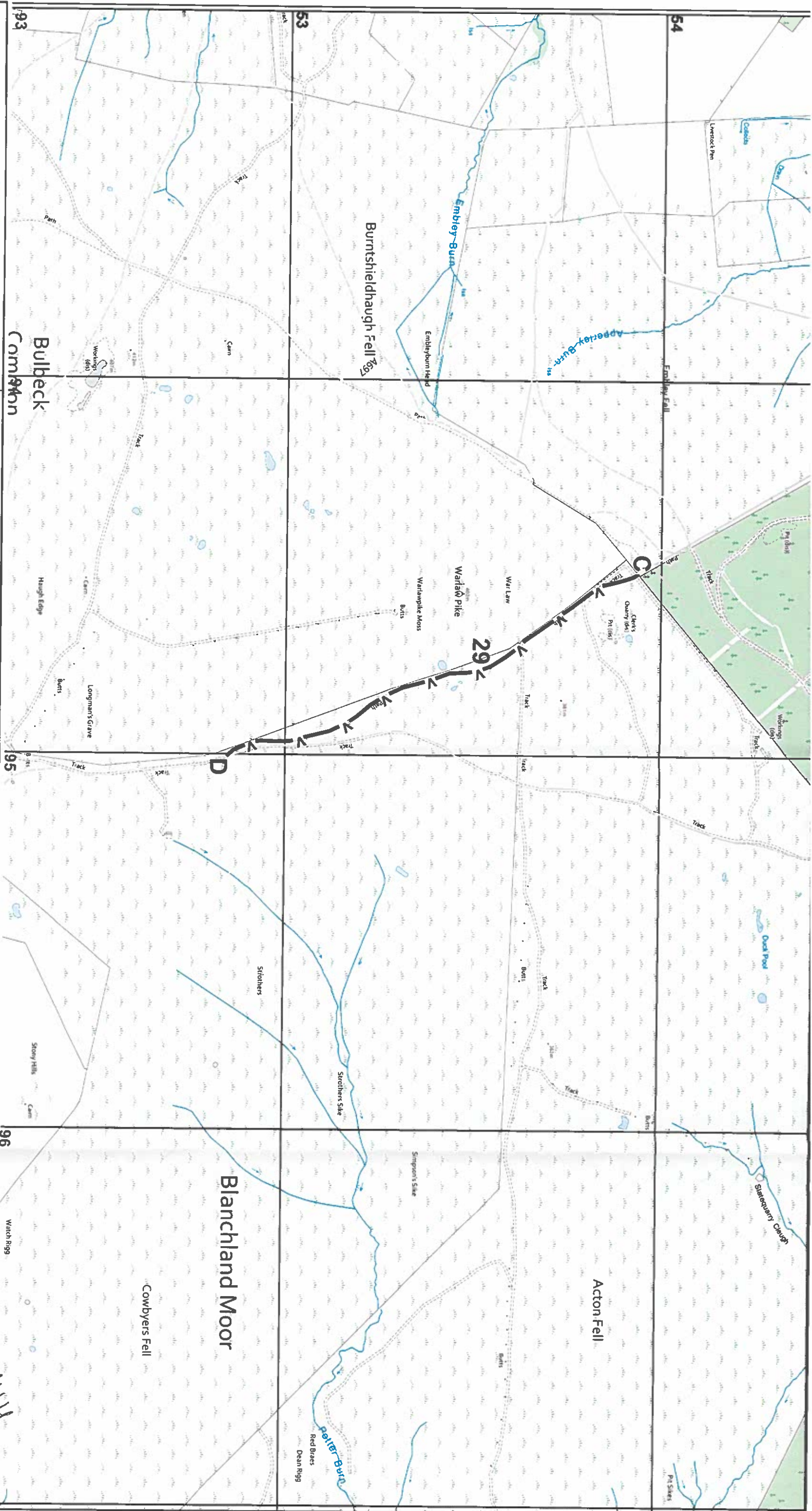

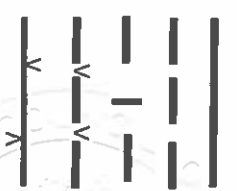
