Definitive Map Modification Order (No 3) 2024

Public Bridleways Nos 33 & 42 (Parishes of Brinkburn & Rothbury)

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(i), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 January 2024.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 3) 2024.

Definitive Map Modification Order (No 3) 2024

Description of Modification to Definitive Map and Statement

Former Alnwick District

Rothbury Bridleway No 42 (NU 00 SE)

Part I Map: Adding thereto a public bridleway, from a point marked V, on the U4066 road, 210 metres north-west of Wagtail Farm, in a general south-easterly direction for a distance of 1660 metres, to a point marked W, on alleged Public Bridleway No 33 in the Parish of Brinkburn, 120 metres south-west of Craghead.

Part II Statement: To be prepared as follows:
A 4 metre wide public bridleway, from the U4066 road, 210 metres north-west of Wagtail Farm, in a south-easterly direction for a distance of 40 metres to the dismantled railway. Thereafter as a 5 metre wide, briefly reducing to 4 metres wide where it crosses small bridges, bridleway, in a south-easterly, then easterly, then south-easterly direction along the dismantled railway for a further 1620 metres, to join Public Bridleway No 33 in the Parish of Brinkburn, 120 metres south-west of Craghead.

Brinkburn Bridleway No 33 (NU 00 SE / NZ 09 NE)

Part I Map: Adding thereto a public bridleway, from a point marked W, on alleged Public Bridleway No 42 in the Parish of Rothbury, 120 metres south-west of Craghead, in a south-easterly direction for a distance of 880 metres, to a point marked X, at the northern end of the U4038 road, 20 metres south-east of Brinkburn Station Cottage.


Part II Statement: To be prepared as follows:
A 5 metre wide, briefly reducing to 4 metres wide where it crosses a small bridge, bridleway, from the eastern end of Public Bridleway No 42 in the Parish of Rothbury, 120 metres south-west of Craghead, in a south-easterly direction along the dismantled railway for a distance of 790 metres to a point just north of Brinkburn Station Cottage, then continuing in a south-easterly direction, passing to the east of the cottage, for a further 90 metres, to join the northern end of the U4038 road, 20 metres south-east of Brinkburn Station Cottage.

The County Council of Northumberland in exercise of their powers under section 53 of the 1981 Act, hereby confirm the foregoing Order:
