## **Definitive Map and Statement of Public Rights of Way for the County of Northumberland**

### **The Northumberland County Council**

#### **Definitive Map Modification Order (No 8) 2021**

##### **Byways Open to All Traffic Nos 35 and 22 (Parishes of Harbottle and Netherton)**

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(i)+(iii) namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic; and that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 December 2021.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 8) 2021.

### Definitive Map Modification Order (No 8) 2021

#### Description of Modification to Definitive Map and Statement

##### Former Alnwick District

<b>Harbottle</b>	<b>Byway Open to All Traffic No 35</b>	<b>(NT 90 NE/SE)</b>
Part I	Map:	Adding thereto a byway open to all traffic, from a point marked H, on the U4019 road, 250 metres north of Sharperton Edge farm, in a north-easterly then north-westerly direction for a distance of 790 metres along part of the U4029 road, to a point marked J, on alleged Byway Open to All Traffic No 22 in the Parish of Netherton, 740 metres south-west of Low Burradon.
Part II	Statement:	To be prepared as follows: As a 12.19 metre wide byway, from the U4019 road, 250 metres north of Sharperton Edge farm, in a north-easterly direction for a distance of 30 metres. Thereafter as a 5 metre wide byway, continuing in a north-easterly direction for a distance of 560 metres. Thereafter as a 12.19 metre wide byway in a north-westerly direction for a distance of 200 metres to join Byway Open to All Traffic No 22 in the Parish of Netherton, 740 metres south-west of Low Burradon.
<b>Netherton</b>	<b>Byway Open to All Traffic No 22</b>	<b>(NT 90 NE)</b>
Part I	Map:	Adding thereto a byway open to all traffic, from a point marked J, on alleged Byway Open to All Traffic No 35 in the Parish of Harbottle, 740 metres south-west of Low Burradon, in a general north-easterly direction along part of the U4029 road for a distance of 1140 metres, to a point marked K, on the C179 road, 270 metres west of Burrdon Hall.
Part II	Statement:	To be prepared as follows: As a 12.19 metre wide byway, from Byway Open to All Traffic No 35 in the Parish of Harbottle, 740 metres south-west of Low Burradon, in an easterly direction for a distance of 120 metres, then northerly direction, through the Foxton Burn, for a distance of 60 metres. Thereafter, as a 5 metre wide byway, in a northerly direction for a distance of 390 metres to the Thackwell Burn, then in a north-easterly direction for 280 metres to Low Burradon. Thereafter, as a 9.14 to 10.5 metre wide byway in a north-easterly direction for a distance of 25 metres. Thereafter, as a 9.14 metre wide byway continuing in a north-easterly direction for a distance of 265 metres to join the C179 road, 270 metres west of Burrdon Hall.

Part I      Map:      The Map is not affected.

Part II      Statement:      To be amended as follows:  
From the Sharperton – Sharperton Edge road north-east of Sharperton Edge, in a north-easterly direction, through Sharperton Edge Plantation, to a bend in Byway Open to All Traffic No 35, then on, for a short distance, to join Public Footpath No 10 in the Parish of Netherton.

**Netherton**                      **Bridleway No 4**                      **(NT 90 NE)**

Part I      Map:      The Map is not affected.

Part II      Statement:      To be amended as follows:  
From Bridleway No 16 in the Parish of Harbottle, in a north-easterly and south-easterly direction to join Byway Open to All Traffic No 22 (the Burradon – Sharperton Edge road).

**Netherton**                      **Footpath No 10**                      **(NT 90 NE/SE)**

Part I      Map:      The Map is not affected.

Part II      Statement:      To be amended as follows:  
From Footpath No 25 in the Parish of Harbottle, in a north-easterly direction to join Byway Open to All Traffic No 22 (the Low Burradon road) west of Greenlish Plantation.

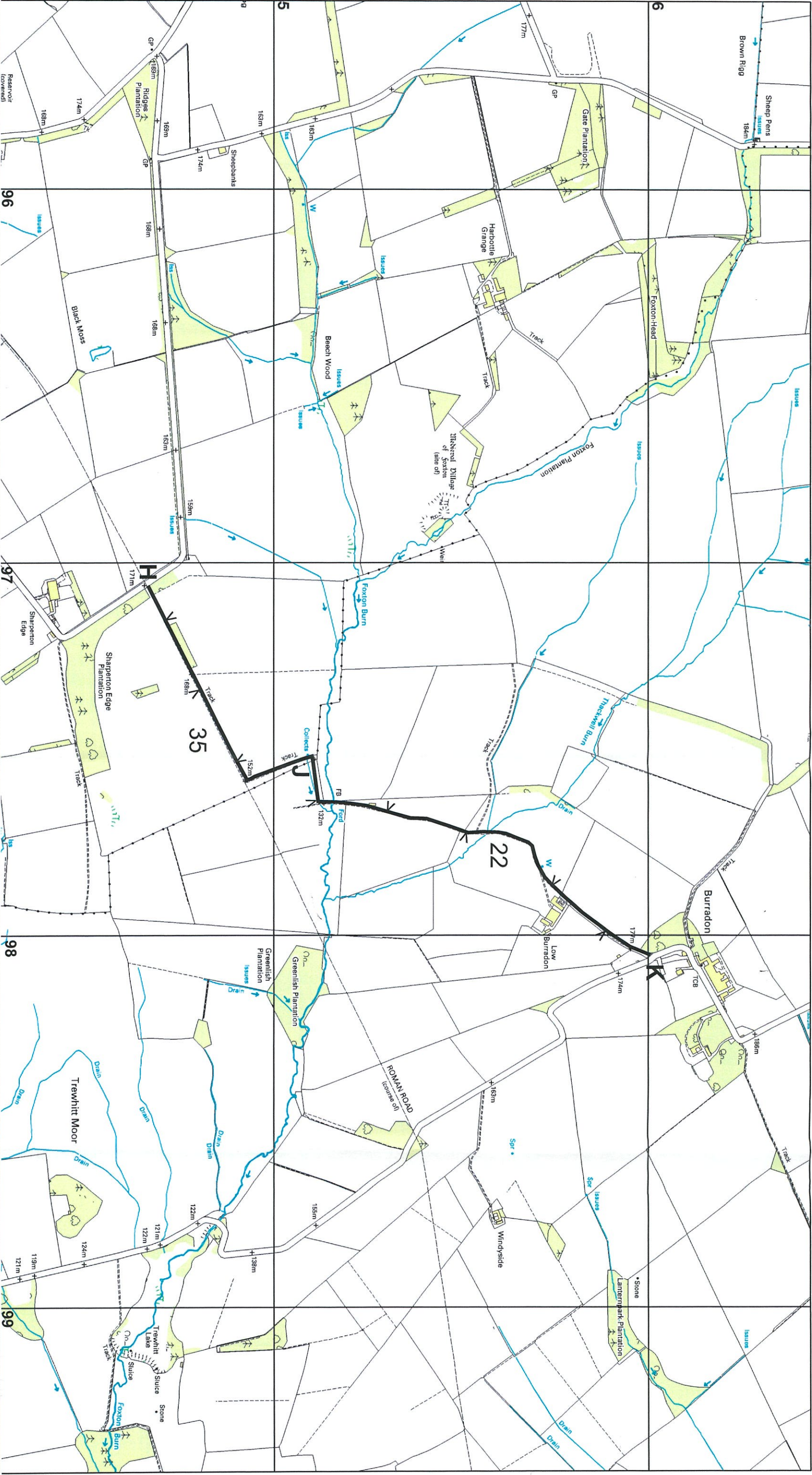
