A foster carer's job is to look after children who can't live with their own family. Foster carers will do all they can to help you feel safe and cared for while you are away from your family.



They will listen to what you say and help you to stay in touch with your family.

Rosie and Jack started to feel happier living with Helen and Michael.

Every Monday and Wednesday Helen took Rosie and Jack to see their Mammy and Daddy at the Children's Centre.



Rosie knew that if she was unhappy about anything Helen and Michael were there to help her.

She could also talk to Laura, her Social Worker.

One day there was a meeting with lots of people. They all thought very hard about Rosie and Jack.



They decided that it was not safe for Rosie and Jack to live with their mammy and daddy.

They decided that Rosie and Jack should have a new family who they could live with forever.

Laura went to court to speak to the judge who also agreed that they should have a new family.




Laura and another social worker looked very hard to find Rosie and Jack a new family who could keep them safe and happy.
