### **Ofsted: Inspecting safeguarding**

Updated in June 2015 to align with the new OFSTED framework which will be in place from September, this guidance provides important information about OFSTED's expectations during a section 5 inspection. Key points include:

- Clarification of what is considered the signs of **successful safeguarding arrangements**
- The evidence the inspectors will look for during an inspection, including what they will look for when considering how leaders and governors create a **safeguarding culture**

## What is the Local Safeguarding Children Board (LSCB)?

... a **statutory** body made up of agencies which work with children

and young people and which agree how they will cooperate to safeguard and promote the welfare of children. The agencies are:

#### What are the priorities of the LSCB?

- co-ordinating the activities of all agencies concerned with the protection of children;
- developing and agreeing local policies and procedures;
- assuring the quality of child protection services;
- raising awareness in the wider community of the need to safeguard children.

#### How does the LSCB carry out its work?

There are currently 8 sub-committees of the LSCB with representation from all partner agencies and which deliver on locally agreed actions to safeguard children:

- 1. Business sub-committee
- 2. Communication and engagement subcommittee
- 3. Serious case review sub-committee
- 4. Learning and development sub-committee

- 5. Performance and quality assurance subcommittee
- 6. Think family sub-committee
- 7. Vulnerable adolescents sub-committee
- 8. Early help and early intervention subcommittee

#### How can education settings get involved?

The LSCB is in the process of creating a new subcommittee for education to involve schools, academies and alternative providers more effectively with the work of the Board and its multiagency partners.

Priorities for the work of this sub-group will include:

- Assessing the effectiveness of help provided to children and young people, including early help
- Assessing whether NSCB agencies are fulfilling statutory obligations
- Quality assuring practice through audits, including the S11
- Developing and agreeing local policies and procedures

The LSCB would like one Designated Safeguarding Lead (DSL) from each Education Partnership to be a sub-committee member. Invitations to the first meeting in September will be e-mailed to identified DSLs in July.

# **Prevent Duty**

The Prevent duty is the duty in the Counter-Terrorism and Security Act 2015 on specified authorities, in the exercise of their functions, to have due regard to the need to prevent people from being drawn into terrorism.

Non-statutory advice is available in the Department for Education document here.

Northumberland schools/academies/alternative providers are required to:

- complete a Prevent self assessment tool (return to <u>Gill Finch</u> by 23<sup>rd</sup> October 2015)
- adopt and adapt a Prevent model policy

# Ofsted whistleblowing

An increasing number of complaints from parents are received by the Education and Skills Service and LSCB via Ofsted's whistleblowing team. During this last academic year it was evident that section 5 inspectors were aware of these complaints when inspecting our schools. Ofsted's whistleblowing process and Northumberland's response to those complaints were published to schools in the guidance document:

Arrangements for the quality assurance of safeguarding standards in Northumberland schools, academies, and alternative education providers have been developed in partnership with the LSCB and settings in response to local and national requirements for keeping children safe from harm.

The role of the Education and Skills Service is to act as a partner agency of the LSCB to quality assure the safeguarding standards in education settings. The safeguarding standards audit resource - **SECTION 11** - helps you to review and monitor current safeguarding arrangements and identify areas which might

need strengthening. The resource corresponds to the safeguarding duty introduced in Section 11 of the Children Act 2004 and the section 5 inspection framework for schools (Education Act 2005).

Settings and the Education and Skills Service are required to report these standards to the LSCB on an annual basis. You should return your completed annual audit to <u>Carol Leckie</u> by 17<sup>th</sup> July 2015.

The Education Service uses the section 11 process as a vehicle to explore safeguarding issues which might arise in individual settings, for example complaints received through the Ofsted Whistleblowing team. A three tier level of response is outlined in the document **Safeguarding Standards in Schools**, **Academies and Alternative Education Providers** (available to view and download on the Information for Schools page of the LSCB webpages).

If you think a child or young person is being abused or mistreated or you have concerns about the safety or welfare of a child, you must speak to someone immediately.

# Child Sexual Exploitation CSE

For every school/academy/alternative provider in Northumberland it is mandatory for at least one member of staff to have completed CSE training.

In March 2015 the Director of Education and Skills wrote to you via the e-courier to communicate this expectation with a deadline of 31<sup>st</sup> May 2015 for completion of the training.
