# **DOMESTIC ABUSE**

### Introucing a NEW INTEGRATED DOMESTIC ABUSE SERVICE FOR NORTHUMBERLAND

Northumberland County Council continues to commit to supporting people who are experiencing or who are at risk from domestic abuse, with the development of a new integrated flexible service.

In line with other local authorities, the council has brought together individual service provision to develop a hub that delivers an integrated service for both female and male victims over the age of 16.

The new service includes a single point of access for all referrals 24 hours a day 7 days a week, safe refuge accommodation, dispersed accommodation, resettlement into the community and outreach support, as well as Independent Domestic Violence Advisors to support people identified as high risk.

The new service, delivered by Places for People Living + will work in partnership with the council, Northumbria Police, NDAS, Cygnus and other voluntary, community and statutory organisations to deliver a whole system response to domestic abuse in Northumberland.

# **KEEPING CHILDREN SAFE IN EDUCATION**

As you will be aware the DfE are currently consulting on changes to KCSiE and you can still contribute (until 22/2/2018) at <a href="https://consult.education.gov.uk/safeguarding-in-schools-team/keeping-children-safe-in-education/">https://consult.education.gov.uk/safeguarding-in-schools-team/keeping-children-safe-in-education/</a>

The key changes proposed include:

- what to do if you have a concern about a child more detailed guidance for staff on the role of early help and the processes for making a referral;
- Children Missing Education schools will be required to hold more than one emergency contact;
- Sexual Harassment and Sexual Violence in Schools the guidance will be updated to reflect the new 'Sexual violence and sexual harassment between children in schools and colleges' published in December 2017;
- children with special educational needs and disabilities (SEND) there will be clear guidance in relation to the use of restraint, especially when considering children with SEND;
- Safer Recruitment there are several areas being strengthened:
  - the new guidance reinforces the mandatory requirements for the single central record;
  - there will be minor changes to clarify the differences between prohibitions, directions, sanctions and restriction;
  - there will be clearer advice on which pre-employment checks are necessary, particularly in relation to DBS checks;
  - there will be clearer advice on references and how to ensure these support the safe appointment of suitable staff;
- host families additional guidance will be provided to clarify how schools can minimise the risk of harm to children taking part in school exchange visits;
- allegations of abuse made against teachers and other staff there will be more information provided to support schools including clarification on their duties as an employer.

The consultation also seeks views on possible extensions to the guidance provided on online safety and seeks professionals' views on the size and scope of KCSIE and the appropriateness of overseas checks

Please ensure you continue to use the September 2016 version until the changes are confirmed

### YOTI App

Childline and the Internet Watch Foundation have come together to provide a service where children can request the removal of sexual images of themselves which have been shared online. As part of that process the child would be asked to provide a link to where the image is stored online, rather than send the image itself.

The child is also required to verify their identity and age and this is done through the YOTI app. YOTI will not store images of the child's ID following the verification process.

The Schools' Safeguarding and Wellbeing team provides services to create environments where vulnerable pupils are safe to learn and monitors safeguarding standards in schools.





# SAFEGUARDING CHILDREN OUTSIDE OF SCHOOL HOURS

TES have published an article with advice for teachers on what to do if they are contacted by a pupil outside of school hours and there is a safeguarding concern.

If there is an immediate concern for the safety of a child, teachers should call the police immediately and report it to the local authority child protection team: **01670 536400.** 

The article also advises that as with a disclosure that happens in person, teachers should not promise confidentiality and should report the disclosure to the schools designated safeguarding lead as soon as possible.

The rapid evidence assessment includes: **distinguishing characteristics or factors that make children either more vulnerable, or more resilient, to online sexual victimisation**, vulnerability profiles or typologies, based on children's characteristics and behaviours; self-generated sexual material, including the relationship between 'sexting' and/or production of self-generated sexual material and sexual extortion or online sexual solicitation; the characteristics and vulnerabilities of victims of transnational online child sexual abuse.
