Proposed Traffic Calming Measures - Cateran Way, Cramlington

Cabinet Member: Glen Sanderson - Leader of the Council

Purpose of Report

To consider the introduction of Traffic Calming Measures - Cateran Way, Cramlington due to road safety concerns.

Recommendations

It is recommended that Traffic Calming Measures are not introduced on Cateran Way, Cramlington.

Key Issues

- 1. Residents raised safety concerns for both pedestrians and motorists caused by speeding traffic on Cateran Way.
- 2. The scheme was to be funded by Councillor Hepple, through his Members' Local Improvement Scheme allowance.

Background

Concerns had been raised by local residents and Councillor Hepple about excessive vehicular speed and road safety in the Cateran Way area of Cramlington.

Given the concerns raised, Councillor Hepple requested that officers consult residents on the possible introduction of traffic calming measures. The measures under consideration were;

- Option 1 priority build outs.
- Option 2 additional road markings.

Also speed surveys were undertaken and these have provided evidence that vehicles are exceeding the current 20mph speed limit. A copy of the survey results are attached in Appendix A.

Consultation

A consultation letter was sent to 969 residents and 22 statutory consultees inviting comments on the viability of introducing Traffic Calming Measures on Cateran Way, Cramlington. A copy of the consultation letter and plans are attached in Appendix B.

450 responses were received with 139 in favour of Option 1, 86 against Option 1, 100 in favour of Option 2 and 125 against Option 2. A summary of the responses is attached as Appendix C.

The results of the consultation were discussed with Councillor Hepple, who agreed that the restrictions should not be introduced given that the feedback received did not have an appetite to proceed with either option.

Proposed Traffic Calming Cateran Way, Cramlington

Residents have raised concerns with County Councillor Allan Hepple regarding vehicles being driven at excessive speeds on Cateran Way, Cramlington causing a traffic safety issue. Councillor Hepple has therefore requested some form of traffic calming in order to address these concerns.

I am therefore writing in accordance with Regulation 5 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 (as amended) to formally ask for your comments on the proposals, to introduce traffic calming on Cateran Way, Cramlington as shown on the attached plans.

Option 1 - Proposed priority buildouts, which would allow room for only 1 vehicle to pass at these points, i.e. traffic in one direction must give way to vehicles in the opposite direction.

Option 2 - Additional road markings.



Can we number them 1-5 with 1 being nearest the entrance to the estate and 5 being the southernmost, to make the discussion a bit clearer? Numbers 1 & 2 are well placed and would have a positive effect and would not interfere with parking. Number 3 would wipe out existing parking space on the western side of the street, where currently around 6-7 cars park, creating a new set of problems. The eastern side of the street is the main part of the road that's used as a thoroughfare for traffic, so it makes no sense to place the buildout on that side. From the Woodhill Road junction southwards the width of the Cateran Way road narrows quite sharply and there is strictly only enough width for two vehicles to pass or one if a car is parked on the road, as they usually are. This is where I live at xx Cateran Way and this is also the area where on-street parking is most dense, which effectively turns the road into a single file road for its remainder. Parked cars mean that traffic needs to adopt a "stop-go" & giving way approach with oncoming traffic to negotiate this section of the road. The position of buildouts 4 & 5 would have a catastrophic effect on the flow of traffic through this section of the road and would have the added negative effect of creating additional parking problems. You'd just be swapping one problem (speeding) that happens on occasion, for another problem that would be permanently in effect. The placement of these buildouts has not been properly thought through, and for that reason I have strong opposition to Option 1.I would not object to the addition of road markings at Option 2 but I question how effective they would be. The existing markings are completely ignored by some drivers. I think they'd be a waste of money. I think the best option would be the placement of lateral road humps that run across the whole width of the road (not those square cushions that destroy wheel alignments on cars). 					OPTION 2 - Fully support traffic calming measures on Cateran Way using initially road paint. I would suggest extra white centre road markings on the corners @37/39 & @117/119 as well as clear junction markings along the length of cateran way including Cateran Way into Cragside mews. I don't believe the traffic priority build outs at @15, @31, @57 will have much effect as these areas are already congested with parked cars along the narrow section @5 to 37 and along to @69 which still does stop the some 'racers' doing crazy speeds through the narrow road area.
