Introduction of a new 20 MPH Speed Limit Restriction at Chollerton First School

Purpose of Report

This report sets out the background to the proposed implementation of a new 20 MPH speed limit adjacent to Chollerton First School, Barrasford.

Recommendations

It is recommended that the new 20 MPH speed limit is introduced adjacent to Chollerton First School including the surrounding area.

Key Issues

1. The provision of a permanent 20 MPH speed limit adjacent to Chollerton First School is in line with the County Council's current policy.
2. This location would benefit from reduced vehicle speeds in the vicinity of Chollerton First School where Vulnerable Road Users (VRUs) are present.
3. The scheme is supported by County Councillor Gibson, Chollerton Parish Council and Chollerton First School.

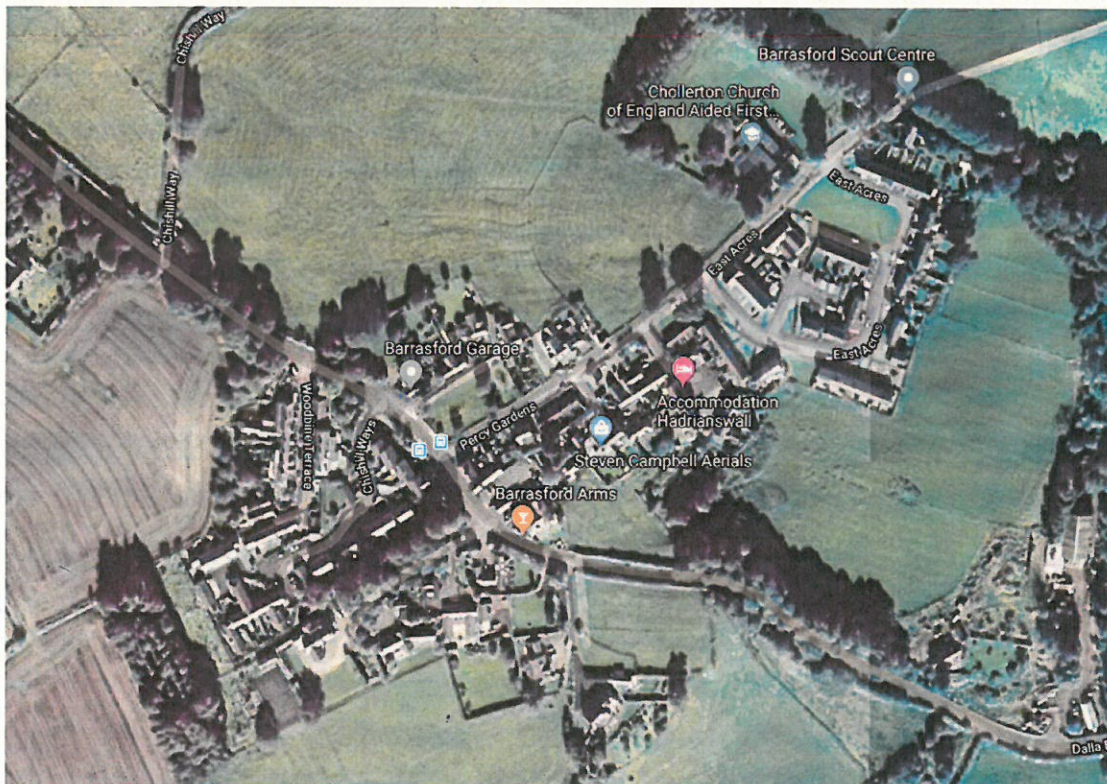
Background

Introduction of 20 MPH Speed Limit

The introduction of a 20 MPH speed limit adjacent to Chollerton First School forms part of the 2019/20 Local Transport Plan. This is part of the County Council's road safety initiative to introduce 20 MPH speed limits adjacent to all schools in Northumberland provided it is feasible to do so.

This scheme will introduce a permanent 20 MPH speed limit adjacent to Chollerton First School, in the area of Station Road as well as the surrounding area. In addition to the permanent 20 MPH speed limit, there is provision within the scheme for an advisory 20 MPH speed limit on the C216 Main Road through Barrasford. This is in line with the County Council's current policy which seeks to improve road safety outside of schools.

Any amendment to the existing signage on the (C216) through the village, (where the speed limit is currently 30 MPH), will be covered by an existing Traffic Regulation Order (TRO) or under the provisions of the Road Traffic Act - Speed Limits and Street Lighting i.e. therefore there is no requirement for an amendment to any existing TRO's for the 30 MPH section of road through Barrasford Village.





Details of the proposals are shown on the plan at Appendix A.

Council Officers have worked closely with County Councillor Gibson, Chollerton Parish Council and Chollerton First School on this scheme.

Northumbria Police, other emergency services and relevant statutory consultees will be notified of these amendments as part of the process for making the permanent Orders.
