#### Introduction of No Waiting Restrictions in Craster Village

#### **Purpose of Report**

This report sets out the background to the proposed implementation of new No Waiting Restrictions (Double Yellow Lines) at the north end of Craster Village.

It is recommended that the new No Waiting Restriction At Any Time (Double Yellow Lines) at the north end of Craster Village.

#### **Key Issues**

- 1. There are issues with indiscriminate parking and sight visibility.
- 2. These additions are in response to concerns raised by the Parish Council.
- 3. The decision to introduce a permanent Traffic Regulation Order is supported by the Parish Council and Councillor Wendy Pattison

## Background

Following concerns raised by local residents via their Local County Councillor and Craster Parish Council, consideration has been given to problems caused by parking at the north end of Craster Village. These issues are causing a number of road safety issues, including poor visibility at junctions and indiscriminate parking.

The areas of most concern are at the junction of the C76/C74 and the C74 road from Craster to Dunstan, where during busy periods in the village, indiscriminate parking along the verges are causing road safety issues.



## Approaching the C76 northbound from Craster Village

This matter was discussed between NCC Officers, County Councillor and Craster Parish Council. It was agreed to introduce No Waiting Restrictions At Any Time (Double Yellow Lines).

Notification of these changes will be advertised as part of the legal process of making this Permanent Traffic Regulation Order.

#### **Delegated Decision**



Approaching the Water Treatment Plant northbound from Craster. During busy periods vehicles park on both verges causing road safety concerns.

Details of the new restrictions are shown on the plan in Appendix A.

Northumbria Police, other emergency services and relevant statutory consultees will be notified that this new Traffic Regulation Order.
