#### **Introduction of No Waiting Restrictions in Doxford Place Cramlington**

#### **Purpose of Report**

This report sets out the background to the proposed implementation of new No Waiting Restrictions (Double Yellow Lines) in Doxford Place Cramlington.

#### **Recommendations**

It is recommended that the new No Waiting Restriction At Any Time (Double Yellow Lines) in Doxford Place Cramlington, be implemented.

#### **Key Issues**

1. There are issues with indiscriminate parking and sight visibility.
2. These additions are in response to concerns raised by local residents and road users.
3. The decision to introduce a permanent Traffic Regulation Order is supported by County Councillor Swinburn.

### **Background**

Following concerns raised by local residents via their Local County Councillor. This issue is causing a number of road safety issues, including poor visibility at junctions due to indiscriminate parking.

This matter was discussed between NCC Officers and County Councillor Swinburn. It was agreed to introduce No Waiting Restrictions At Any Time (Double Yellow Lines). This is also supported by the SCEO Parking Services, who highlighted the fact that the issue was exacerbated at school starting and finishing times, with vehicles either parking or turning at this junction.

Notification of these changes will be advertised as part of the legal process of making this Permanent Traffic Regulation Order.

Details of the new restrictions are shown on the plan in Appendix A.

Northumbria Police, other emergency services and relevant statutory consultees will be notified that this new Traffic Regulation Order.

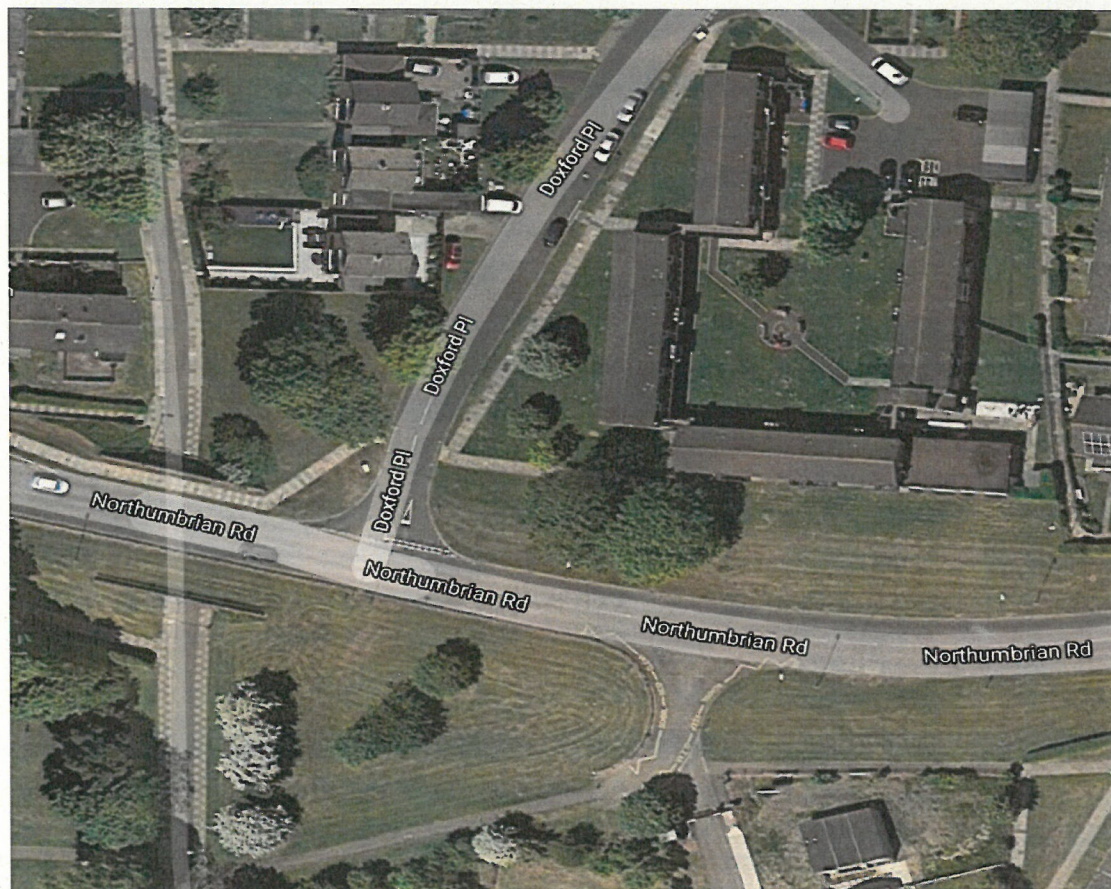
### **Junction Doxford Place and Northumbrian Road Cramlington**


