#### **DECISION REPORT**

**Proposed 'No Waiting at Any Time' Parking Restrictions,  
Dunlin Drive, Blyth**

#### **Purpose of Report**

To consider the introduction of 'No Waiting at Any Time' parking restrictions at junctions on Dunlin Drive in Blyth due to road safety concerns.

#### **Recommendations**

It is recommended that the proposed 'No Waiting at Any Time' (Double Yellow Lines) parking restrictions are introduced at junctions on Dunlin Drive in Blyth.

#### **Key Issues**

1. Residents have raised safety concerns for both pedestrians and motorists caused by parked cars on Dunlin Drive.
2. The scheme is to be funded by Councillor Reid, through his Members' Local Improvement Scheme allowance.

### Background

Residents contacted their local Ward Member with concerns regarding safety issues for both pedestrians and motorists caused by congestion and indiscriminate parking on Dunlin Drive.

Indiscriminate parking on the road is making it difficult for residents, visitors and general road users to negotiate this road safely, causing visibility issues especially at junctions.

After meeting with Councillor Reid, council officers proposed that 'No Waiting At Any Time' parking restrictions be introduced to alleviate these concerns.

### **Consultation**

A consultation letter was sent to 60 residents and 25 statutory consultees inviting comments on the viability of introducing 'No Waiting at Any Time' parking restrictions (Double Yellow Lines) on Dunlin Drive. A copy of the consultation letter and plan are attached in Appendix A.

22 responses were received with 19 in favour and 3 against the proposal. A summary of the responses is attached as Appendix B.

The results of the consultation were discussed with Councillor Reid, who agreed that the restrictions should be introduced as proposed.

The scheme is supported by Councillor Reid and funded through his Members' Local Improvement Scheme allocation.

**Proposed No Waiting at Any Time Restrictions,  
Dunlin Drive, Blyth**

Concerns have been raised with County Councillor Reid, regarding vehicles being parked on the junctions of Dunlin Drive, causing potential traffic safety issues. It is reported that vehicles are having difficulty negotiating this area safely. Councillor Reid has therefore requested that "No Waiting at Any Time" restrictions be introduced on this road in order to alleviate these concerns.

I am therefore writing in accordance with Regulation 5 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 (as amended) to formally advise you on the proposed introduction of "No Waiting at Any Time" parking restrictions on Dunlin Drive, Blyth as shown on the attached plan.

The County Council is seeking your views on the proposals and a freepost response form is attached to facilitate the consultation process. It should be stressed that this is a genuine consultation and that comments received will be carefully considered.

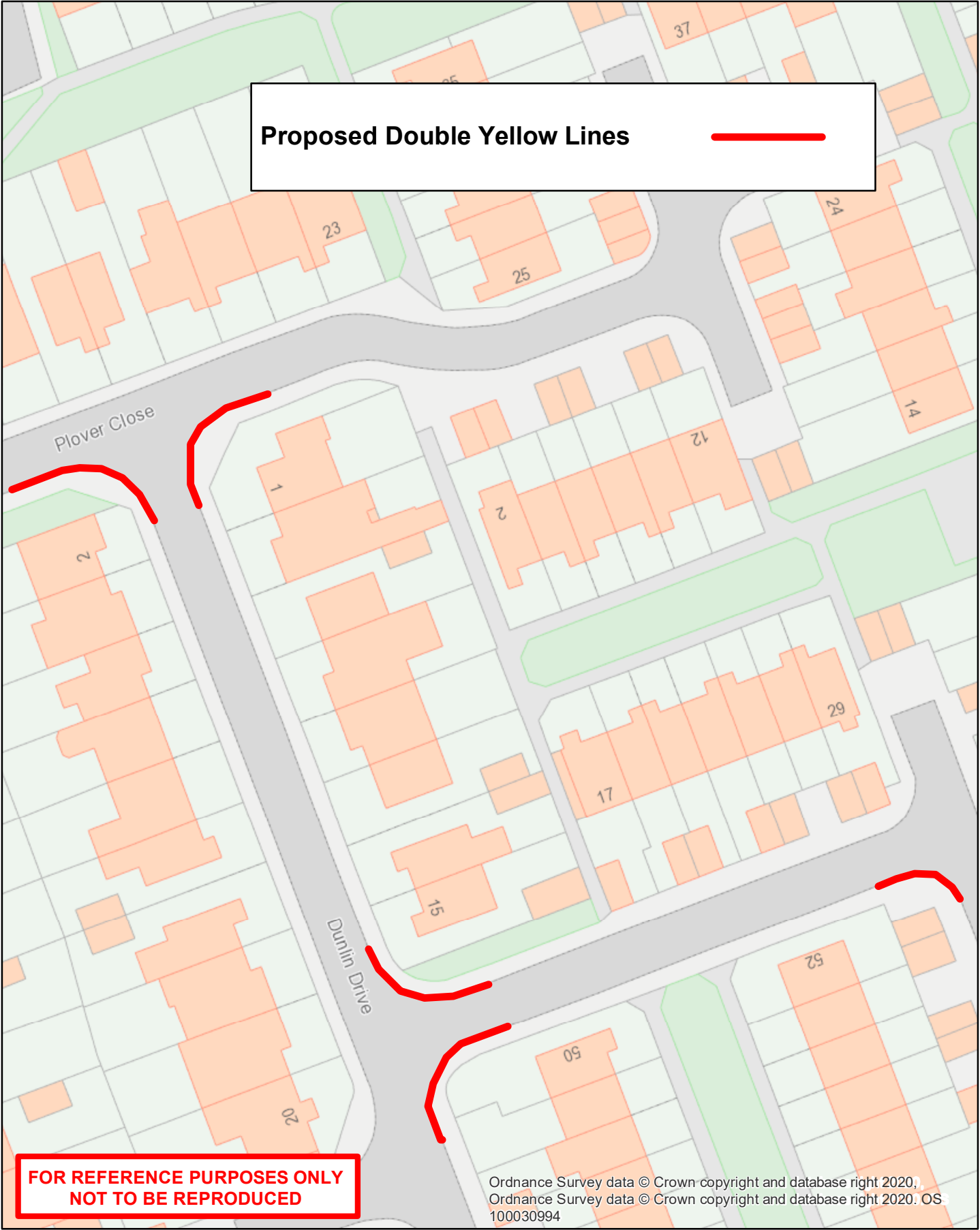

Move should be done to limit the traffic coming into the Estate and promote responsible parking as parents/careers etc. park all over the place. Stricter enforcement of parking restrictions needs to be implemented and maintained.

	1			This will be most welcome as delivery vehicles such as furniture wagons, large goods, building supplies have great difficulty negotiating parked cars etc. The wheelie bin emptying is also a challenge as I am sure your employees must have reported. The School run adds to the congestion around our street.

NE24 3SQ	1			My only concern is that the residents who currently park vehicles at the junctions will simply move them to somewhere along the street. A note from the Council advising Homeowners that will one park their vehicles Infront of their own homes would help,
NE24 3SN	1			We have lived at this address since 1976 and have watched the traffic increase over the years, mostly in the later ten to fifteen years. It's not just private cars, as some homes now have two or three vehicles, but business vehicles, vans small lorries and pickups. Are to be found especially in the evening and mornings. On top of this as we live on one of the corner's in Dunlin drive we have to contend with the "Bede Academy" school run twice per day with vehicles parking over the access to our residence. We therefore would be agreeable to double yellows and parking restrictions before a serious accident occurs. Also we would like double yellows placed on the road right across the entrance to or property at the rear. There is also the kerbs being broken with parking (two wheels) on pavement and narrowing for pedestrians using the pavement!

NE	1			The lack of parking in the triple cul de sac area of Dunlin Drive behind numbers X,X has been problematic for a number of years. While we feel that the introduction of the double yellow lines may exacerbate this problem, we feel that is the right thing to do for people's safety. We might also support adding an extra set of double yellow lines to the adjacent corner surrounding number X Dunlin. This a rented property where the tenants owns approx. 4 vehicles and appears to be running a mechanics workshop form his garage - this regularly leads to a buildup of cars on this corner and sometimes in the middle of the road, blocking access completely.

I make this comment because to access Dunlin Drive you must turn into Plover Close, when you entre Plover Close there is a No Entry Except for Access to Off- Street Premises sign which I assume does not mean you can park here to go and pick your kids up from school. When I get home from work on a Friday afternoon about 3.30pm it is sometimes chaotic with cars parked anywhere including the double yellow lines on the corners of Plover Close and Curlew Way so unless it is enforced I feel nobody will take any notice. In the last couple of years entering or leaving the estate on Curlew Way has become harder at School times as you have a lot of cars coming in and out and the drivers at times will not stop to let you past and when they queue to get in or out they quite often just pull up alongside a parked car so no can move.
