Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1) and 2 and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

**1. Commencement and Citation**

This Order shall come into operation on the 6<sup>th</sup> February 2017 and may be cited as "Northumberland County Council Welfare Crescent Newbiggin by the Sea (One Way Traffic Restriction) Order 2017".

**2. In the Order:-**

"Order" means "Northumberland County Council Welfare Crescent Newbiggin by the Sea (One Way Traffic Restriction) Order 2017".

"Specified" means specified in the Schedule to this Order

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

**3. Provisions**

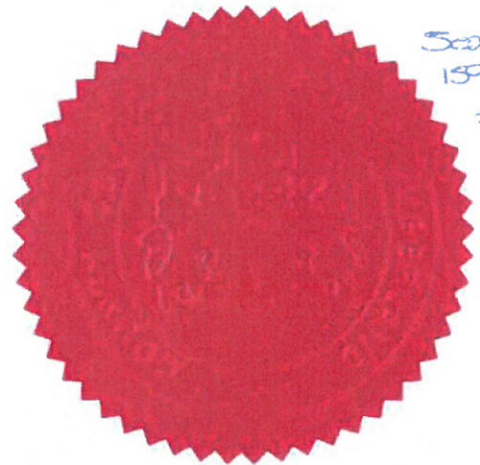
No person shall cause or permit a vehicle to proceed in any specified road or in any specified length of road in a direction other than that specified in relation to that road or length of road as shown in the Schedule attached to this Order.

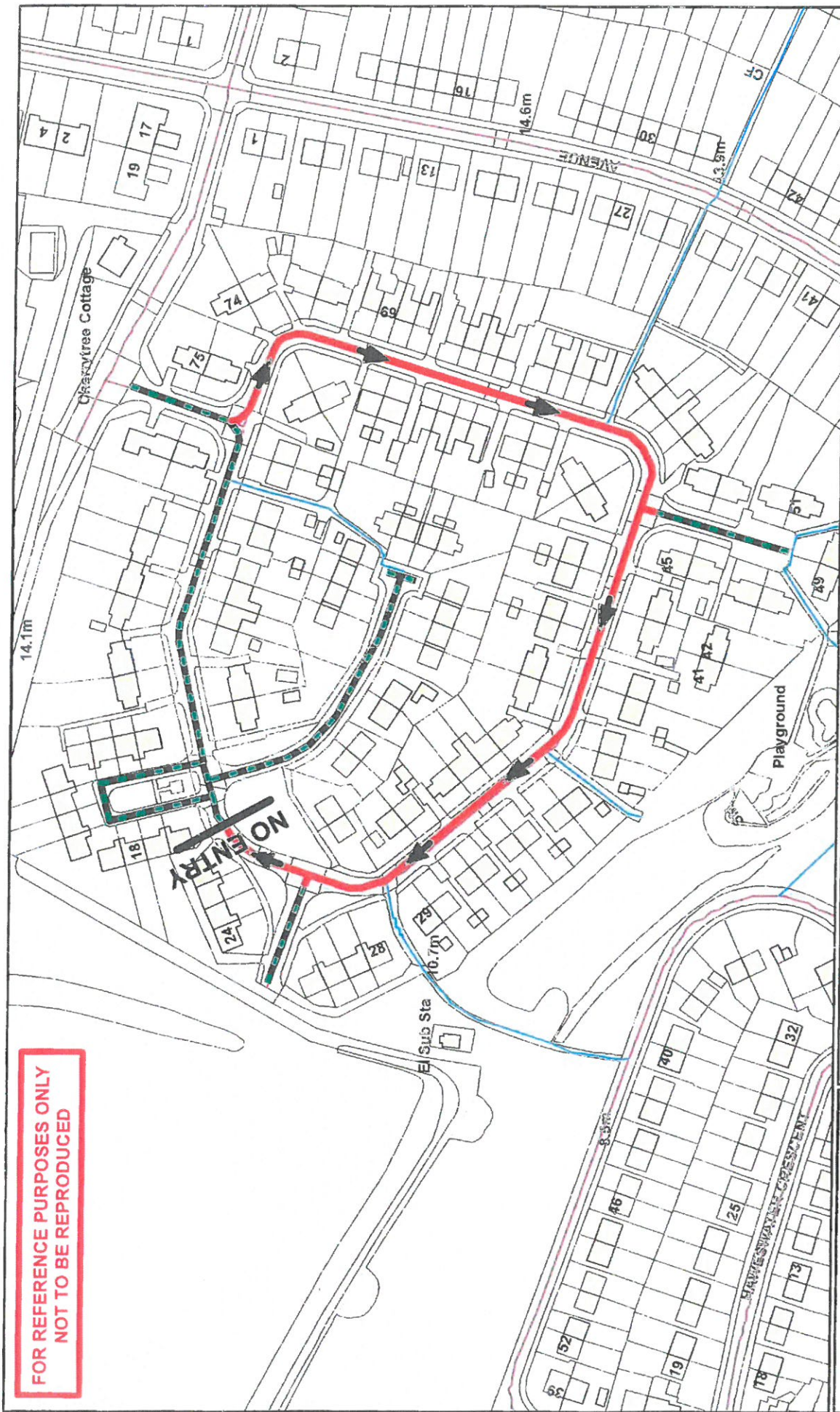
