

**NORTHUMBERLAND COUNTY COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984  
(MORPETH RUGBY FOOTBALL CLUB PROHIBITION OF DRIVING)  
ORDER 2023 (TROM\_253)**

Northumberland County Council, in exercise of their powers under Sections 1, 2, 3 and 4 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

1.     (1)     This Order shall come into operation on the 20<sup>th</sup> March 2023 and may be cited as "Northumberland County Council (Morpeth Rugby Football Club Prohibition of Driving) Order 2023".  
  
          (2)     Except where otherwise stated, any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.  
  
          (3)     The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2.     Save as provided in Article 3, no person shall cause any vehicle to enter those lengths of highway detailed in The Schedule of this Order.
3.     Nothing in Article 2 shall make it unlawful to cause or permit any vehicle to enter the roads referred to therein for so long as may be necessary to enable:
  - 3.1     any motor vehicle displaying a valid disabled badge, being driven by or carrying a disabled person to uplift or set down passengers or to wait at property or premises situated along the lengths of road described in The Schedule of this Order;
  - 3.2     any heavy goods vehicle to be used to gain any reasonable access to a destination being a private property or any land or premises situated along the lengths of road described in The Schedule, for the purpose of the collection or delivery of goods;
