#### 1. Commencement and Citation

This Order shall come into operation on the 24<sup>th</sup> May 2021 and may be cited as "Northumberland County Council North Northumberland (Southern) Area (Waiting and Loading) Composite Order 2011 – Amendment No 38 Order 2021".
