1. Commencement and Citation

This Order shall come into operation on the 1st June 2021 and may be cited as "Northumberland County Council North Northumberland (Southern) Area (Waiting and Loading) Composite Order 2011 – Amendment No 39 Order 2021".

2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Southern) Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council North Northumberland (Southern) Area (Waiting and Loading) Composite Order 2011 – Amendment No 39 Order 2021".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.



STATEMENT OF THE COUNCIL'S REASONS FOR MAKING THE ORDER

Goose Hill, Morpeth

The Order is necessary in order to improve road safety and the flow of traffic in association with the new off-street car park at the former school site at Goose Hill, Morpeth. This Order also removes the 'School Keep Clear' and Waiting restrictions that were in place to discourage obstructive and indiscriminate parking associated with pick up and drop offs at school start and end times, in turn being replaced by Waiting restrictions which apply at all times.
