Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32 and 35 and Part III and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), Part 6 of the Traffic Management Act 2004 ("the Act of 2004"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

**1. Commencement and Citation**

This Order shall come into operation on the 5<sup>th</sup> September 2022 and may be cited as "Northumberland County Council Off Street Parking Places Composite Order 2014 – Amendment No 18 Order 2022".

**2. In the Order:-**

"Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014".

"Amendment Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014 – Amendment No 18 Order 2022".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

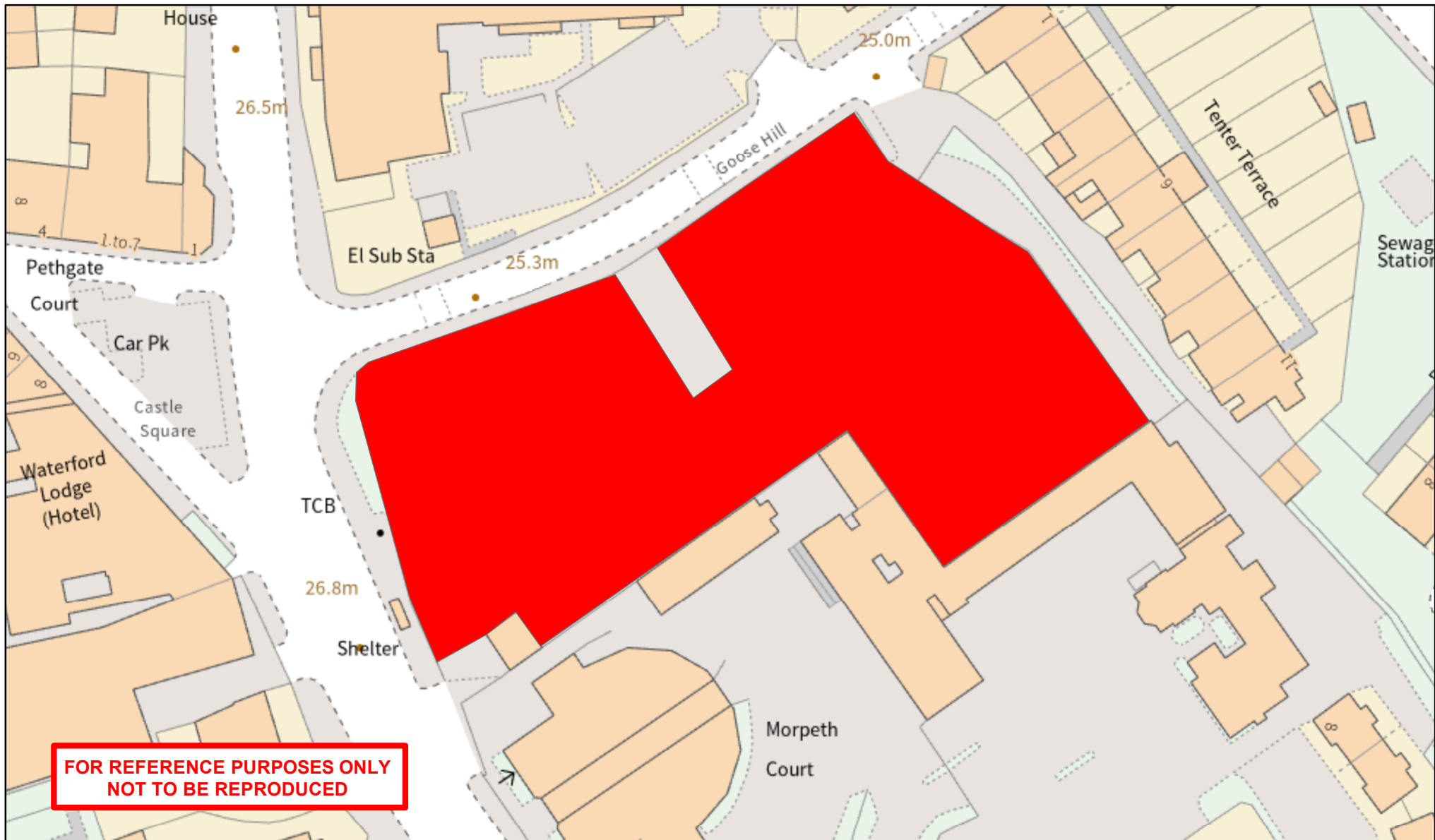
