



These boards provide an update on the proposals by Northumberland County Council for the refurbishment of Newbiggin Sports & Community Centre.

The proposals will provide a modern, flexible leisure, library and community provision for the people of Newbiggin Town Centre.

The proposals will create a new entrance, updated changing facilities with a link to the community hub, along with updated library facilities, sports provision and some essential repairs to the fabric of the building.





Introduction

What facilities will be provided in the refurbished building?

- Creation of a new front of house/reception offer including self-service provision in line with Active Northumberland Transformation programme;
- Relocation of the library to a more appropriate location and enhance the learning environment; •
- Creation of a community café linked to the new library area; •
- Creation of improved changing facilities to support a greater number of concurrent sport and leisure activities with specific changing facilities for outdoor sports, targeted to support AFC Newbiggin;
- Provision of a Changing Places facility to improve accessibility and inclusion;
- Improved sports hall flooring;
- Improved squash court provision; •
- Provision for a new studio space; •
- General refurbishment and redecoration throughout the building; •
- Modifications to mechanical and electrical services resulting from remodelling and refurbishment works;
- A new community allotment area to the rear of the centre. •




PROPOSED LEVEL 00 PLAN NOT TO SCALE

Proposals

Interior Strategy -

Following discussions with Active, Library Services and Northumberland Communities Together, HLP have developed a design which improves facilities and use of spaces for all centre users.


The new entrance and reception will be more functional for both staff and centre users - Activator Pods and self serve screens used in other Active centres have been included.

Improved changing facilities, two of which are located within the new extension on the North elevation and the provision of a changing places room.

Refurbishment of sports facilities - Squash courts, studio & gym. Refresh of sports hall flooring.

The library includes separate areas for both adults and children, PC stations and work desks with integrated power. Self serve machine available for book search.

The cafe area is located directly ahead of the library entrance, which allows seating to be shared. With access from the library the external courtyard is proposed to be used for seating and children's activities.
