## 8. Full Application updates to Executive:

Lesbury Village Hall - planning has been approved and the FA appraisal is in process Joy of Care - delayed due to planning but is now approved and progressing Northumberland County Zoo - expecting planning approval this week and ready for appraisal

IH - reported that all three are expected to come forward by February 2019 or sooner.

Barn on the Bay (grant request £45k) carries the greatest potential risk as there is a general lack of clarity about their business model and the situation regarding planning. IH to contact for updated information.

DB - stated that it should be reiterated to all applicants that LEADER is a competitive process and their application could still be gazumped if others are ready and in a position to advance through the process more quickly.

## 9. Communications Working Group

RB - reported that the 3 press releases prepared for Northumberland News were rejected as they need to be apolitical. They will now be aimed at the Gazette & Herald.

RB also reported on the meeting held with IH and Lorraine Hindhaugh re: the proposed event and also production of a glossy end of programme report.

#### **C&L LAG Event**

Although time may be tight RB still keen to progress the event on 23 January 2019 as planned at Carnaby's. The style of the event will be an awards ceremony so the LAG will need to pick front runners. SC, being conscious of the timescale, questioned whether this could be delivered in time? IH responded that one of RL's key aims in holding the event was to highlight the launch of the consultation on SPF. However no date has yet been given for the consultation and Peter Jackson's availability is in doubt as he has prior diary commitments for that day with North of Tyne. In the light of this IH suggested that C&L LAG arrange a small briefing session for key players on the local political stage by the end of January (or as soon as the SPF consultation launch date is known) and then plan to have an

awards and celebration event at the end of the programme. AW said that IH needs to let RL know that the 23rd Jan is not a realistic date. DB suggested that a joint briefing for Peter Jackson by RL and Terry Carroll (NULAG Chair) under a unified banner of 'Northumberland LEADER' might be a stronger voice in bidding for any possible transition funding from NCC. AW offered thanks to RB for all his work on event planning and communications.

ACTION: IH to keep members briefed on developments around the event & SPF consultation.

ACTION: IH to contact RL to update him on the discussions surrounding the event and SPF.

## 10. Evaluation Working Group:

SC - reported that there were no projects currently on the stocks awaiting evaluation visits. However they are expecting Smailes Secure Storage and Warkworth Cricket Club Mower to be ready for evaluation in the second half of January 2019.

#### 11. A.O.B:

- a) IH is still getting enquiries and when not able to offer LEADER as an option will signpost to other potential funding
- b) Alpha Gym in Amble have an underspend of around £5k so they may ask for a variation to spend up to their full allocation.
