### Chair's Update:

RL - Meeting had with Cllr.Peter Jackson - Leader of Northumberland County Council, Cllr. Richard Wearmouth (NCC) and Terry Carol (NULAG Chair) to discuss the impact of the LEADER Programme. PJ was very supportive.

There is an opportunity in NCC to support as an advocate for the LEADER process before the Shared Prosperity Fund (SPF) consultation. Meeting acknowledged problems around rural funding, suggestion to convene a round table with North East Local Enterprise Partnership (NELEP) to review Community Led Local Development (CLLD) for Northumberland.


Completed online survey on LEADER, what works well, what's not? There is activity in background but it's late in the day.

In contact with NELEP to feed in LEADER information to the Local Industrial Strategy (LIS) and continuing to lobby NELEP for inclusion of CLLD and rural development in the LIS.

AW - Northumberland is unique. Did PJ give an opinion when the SPF would start? RL - No, PJ had no information on the SPF consultation.

Not a disaster for rural if Labour candidate won the North of Tyne Mayor election. Will invite new mayor to forthcoming to LEADER event.

DB - Rural Business Growth Fund - business case being developed

AW - Will that be rubber stamped?

DB - We expect so. Feedback from LEADER Exchange Group (LEG), Defra considering possible transition period but no details

### **5. Programme Officers Report:**

IH - Gave Programme Officers report and informed LAG of current project budget commitment such that C&L is fully committed with Grant Funding Agreements (GFAs) totalling £1,759,853.46 supporting 59 projects. A small amount of project underspend around £10,000,00 is still available to the LAG to commit to projects

DB - LAG are over committed to 103%, can only allocate underspend

RL - Have LAG enough allocation to fund project application tonight or can LAG only allocate underspend?

DB - LAG can only allocate underspend

RL - Can accountable body use future underspend?

DB - Yes, likely to be project underspend so can recycle back into programme Informed LAG meeting that he had a teleconference with RPA who are pleased with the performance of C&L LAG, and that an Operational Note has been circulated confirming a 3rd and final round of national project underspend reallocation, which is likely to be a very limited amount and there is a tight timescale attached. We would need all applications in and ready for technical appraisal and on DORA by 7th June, then RPA will review.


An application form to apply for additional funding needs to be submitted by the accountable body (AB) to the RPA by 14th June and RPA will inform AB of decision by 28th June. There is also a possibility to extend project commitment date to the end of September.

DB - Proposes LAG apply for underspend by 14 June and extension until the end of September. Don't know the criteria for RPA decision to award underspend, potential value for money?

For Information - NULAG have not yet committed their allocation. A conversation needs to happen where they could propose to extend until the end of September or surrender funds to C&L. Process to go through but don't know what their decision will be?

RL - We need to ensure that both applications in process are ready for submission and applicants need to be informed of the need for all applications completed and available by 7th June

DB - Have concerns with time issues for applications as if LAG apply for underspend and then applications don't come through?



IH - Can contact both applicants and ask that applications need to be in and completed by 3rd June, ensuring that they understand there is no guarantee that the LAG will approve funds

RL - Do LAG want to ask for further allocation?

AW - Are we looking to bring any further EOI's forward, how quickly can this happen?

RL - Don't think we have the time?

IH - Can we ask the RPA for additional funds through reallocation for agenda item 7?

**Development of The Nursery at Whitehouse Farm** 

**DORA: 11325** 

**LEADER Priority Theme - Support for Micro Enterprise** 

Total Project Cost - £29,408.72

LEADER Grant Recommended - £11,763.49

Summary - The aim of the project is to expand a private day nursery for children aged 0-5 at Whitehouse Farm Centre to the south of Morpeth, Northumberland. This activity is for preschool age children and is therefore not statutory provision. The project will renovate a large disused barn into a baby unit with a section aimed at up to 3 year olds. The premises are also intended to offer school holiday care.
