The members of the board asked the questions on how long the projects have, what is the normal time for an approval of the project, when is the last contract date? *SB* clarified that the time is usually 4 to 8 weeks for an approval.

SB updated the board about his time at the Bridlington event from the 15<sup>th</sup> to 18<sup>th</sup> May:

**Core EMFF programme:** £45m available with £27m committed and a further £16m in the pipeline (signed applications) and £2.5m for the FLAGs. This represents a possible overspend if all goes well however the MMO factor in a 10 - 15 % fall off rate which may result in £4 - 6m being available, this will be confirmed in due course.

FLAGs: £1m committed with £300k spent.

- September 2018: £776,000 to be spent
- September 2019: £1.279m to be spent.
- Management and Administration claims to be submitted.
- There's a possibility additional funding may be made available to FLAGs due to the Euro / Pound exchange rates, more info towards the end of year.
- Next EMFF / MMO UK Management Authority event will be in England, date and location to be confirmed but will be this year.

## 7. FLAG Progress discussion - all

Questions were asked around how the rest of the FLAGs are doing compared to the North of Tyne. Presently the six English FLAGs have committed £1m with £300k spent.

The North of Tyne FLAG has spent £55k. There are three projects totalling £97k with the MMO awaiting their decision. The three projects approved today by the FLAG for submission to the MMO will add £102k. If these projects are approved this will total £254k, a further £23k is at the EOI stage and £170k at the Full Application stage totalling £448k approximately. The submission of more projects to the MMO and their anticipated approval places the North of Tyne FLAG in a far better position to achieve full spend.

Some FLAGs have had a better start than others for varying reasons however they all remain confident that they will achieve the allocated spend by the programme end date.
