**Former Blyth Valley Borough (Public Footpath No 155)
Special Extinguishment Order 2023**

This Order is made by Northumberland County Council ("the Authority"), under Section 118B of the Highways Act 1980 ("the 1980 Act").

The footpath described in Paragraph 1 of this Order, in the Authority's area, crosses land occupied for the purposes of a school.

It appears to the Authority that it is expedient, for the purpose of protecting pupils and staff from violence or the threat of violence, harassment, alarm, distress or risk to health and safety, that the said footpath should be stopped up.

Cramlington Town Council and Northumbria Police have been consulted as required by Section 120(2) and Section 118B(6) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Cramlington Learning Village and shown by a bold continuous line on the map contained in this Order and described in the Schedule to this Order shall be stopped up after 63 days from the date of confirmation of this Order.

Description of site of existing path or way

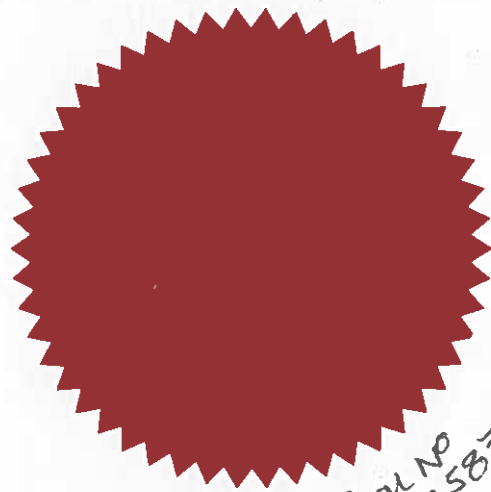
Public Footpath No 155 (Former Blyth Valley Borough)

From a point marked A, at the entrance to the school grounds, 15 metres north of number 18 Ripley Drive, in a general northerly direction for a distance of 520 metres through the school site, to a point marked B, at the school entrance adjacent to the cycle track, 15 metres south-west of number 38 Highburn.

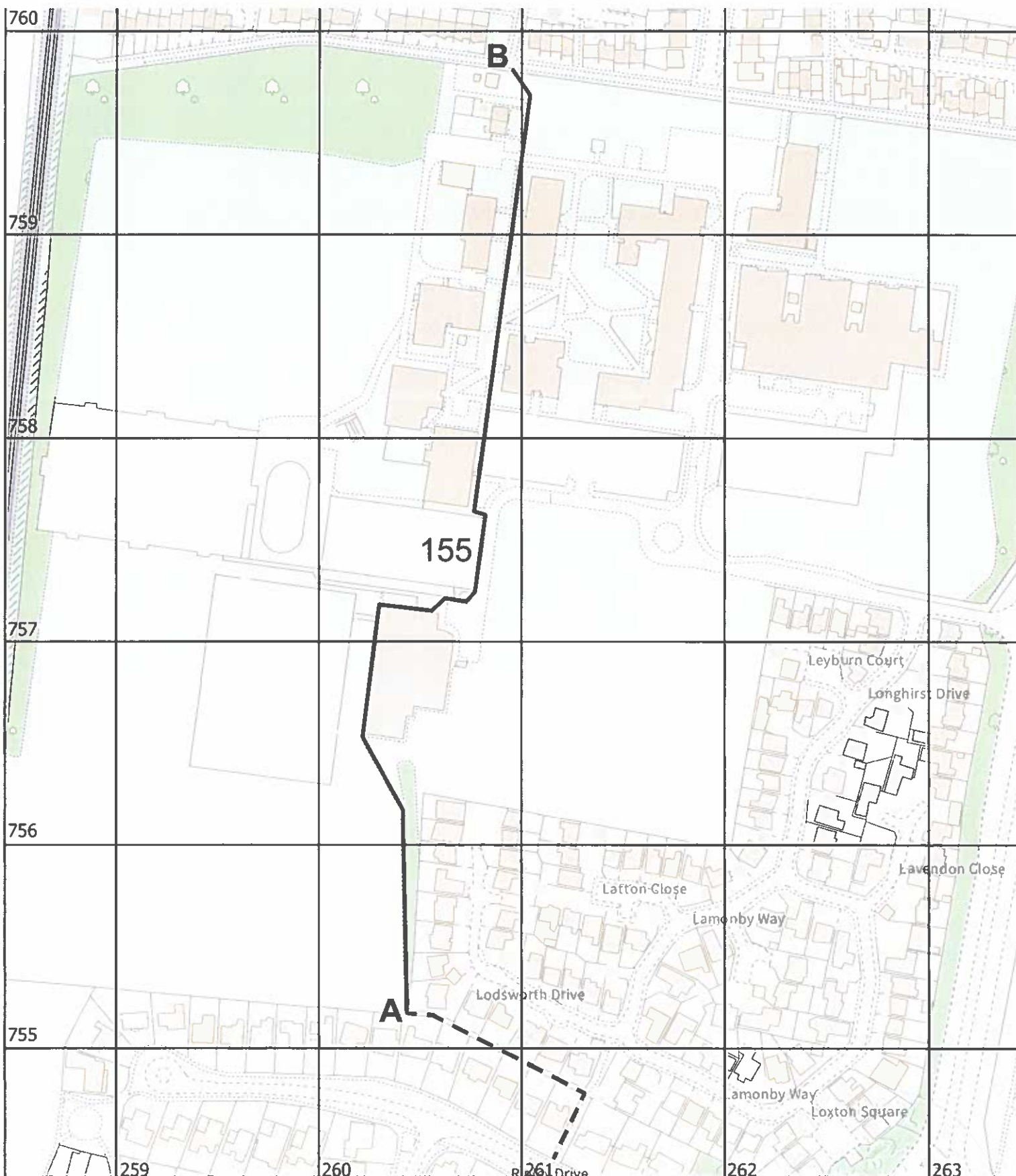
