Definitive Map Modification Order (No 11) 2022

Byway Open to All Traffic / Restricted Byway No 24 (Parish of Doddington)

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(ii) and (iii), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description; and that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

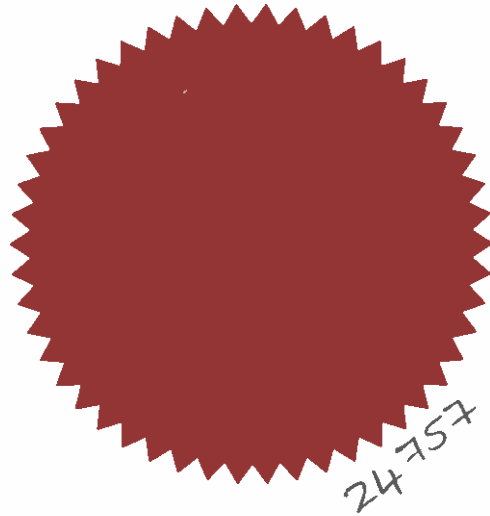
The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 June 2022.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 11) 2022.

Definitive Map Modification Order (No 11) 2022

Description of Modification to Definitive Map and Statement

Former Berwick-upon-Tweed Borough

Doddington Byway Open to All Traffic / Restricted Byway No 24 (NU 03 NW)

Part I Map: Upgrading thereto to byway open to all traffic status, existing Restricted Byway No 24, from a point marked Y, at the northern end of Byway Open to All Traffic No 23, 150 metres south-west of Hetton North Farm, in a northerly direction for a distance of 115 metres to a point marked H, on the U1047 road, 110 metres west of Hetton North Farm.

Part II Statement: To be amended as follows:
A 5 metre wide byway open to all traffic, from the north end of Byway Open to All Traffic No 23, 150 metres south-west of Hetton North Farm, in a northerly direction for a distance of 115 metres to join the U1047 road, 110 metres west of Hetton North Farm.

Doddington Byway Open to All Traffic No 23 (NU 03 NW)

Part I Map: The Map is not affected.

Part II Statement: To be amended as follows:
As a 10 metre wide byway open to all traffic, from the U1051 road, 250 metres north-east of Stewards House, Wrangham, in a north-easterly direction for a distance of 175 metres. Then as a 7.2 to 8.1 metre wide byway continuing in a north-easterly direction for a further 205 metres. Thereafter as an unenclosed 5 metre wide byway in a north-easterly direction for a distance of 620 metres, then northerly direction for a distance of 305 metres, to join Byway Open to All Traffic No 24, 150 metres south-west of Hetton North Farm.

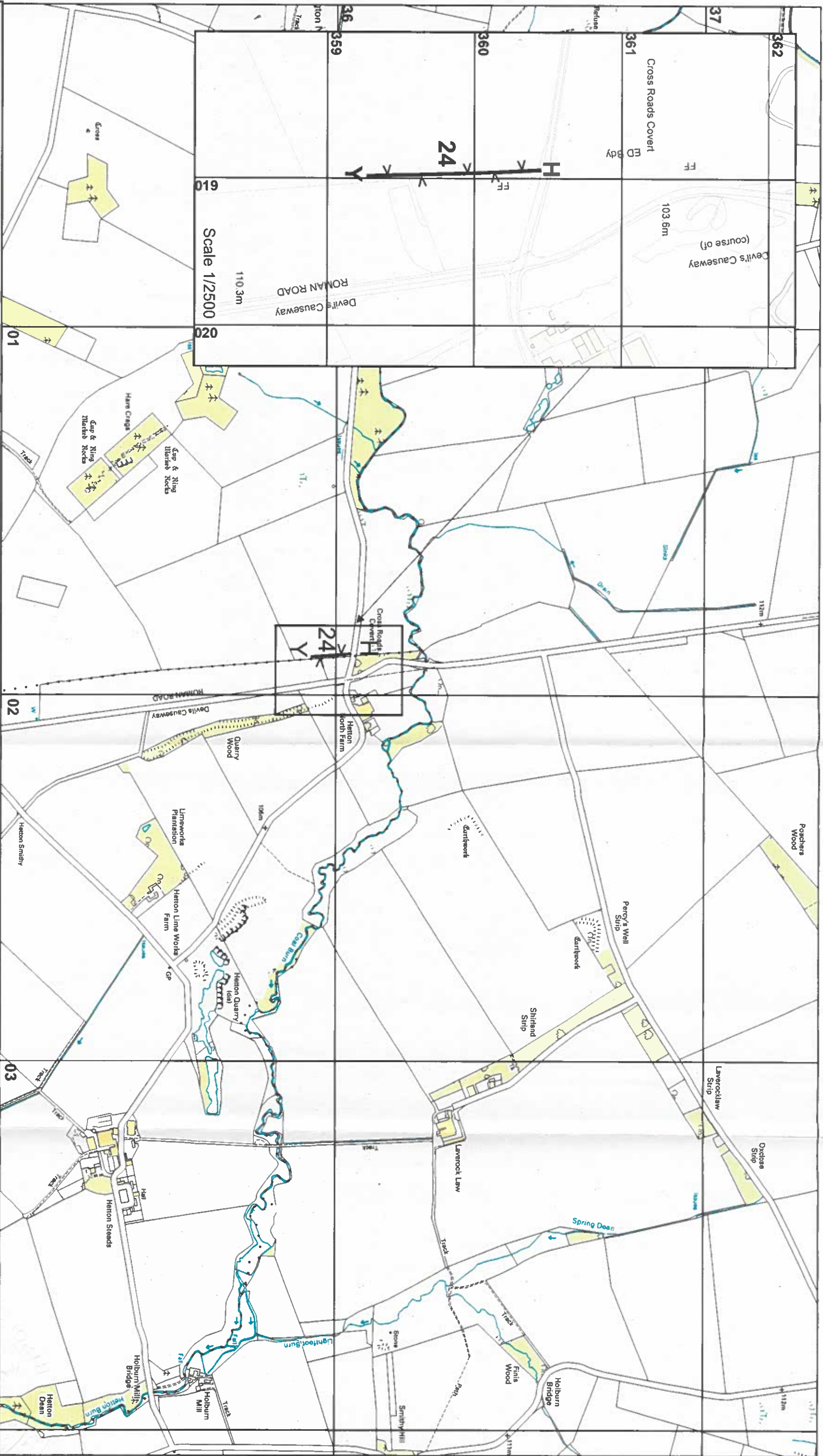
