Definitive Map Modification Order (No 13) 2024

Byway Open to All Traffic No 31 (Parish of Brinkburn)

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(i) and (iii), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic; and that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 November 2024.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 13) 2024.

Definitive Map Modification Order (No 13) 2024

Description of Modification to Definitive Map and Statement

Former Alnwick District

Brinkburn **Byway Open to All Traffic No 31 (NU 00SE / 10SW / NZ 19NW)**

Part I Map: Adding thereto a byway open to all traffic, from a point marked G, on the C188 road, 420 metres west of Healeycote House, in a general north-westerly direction along the U4048 road for a distance of 1960 metres, to a junction with existing Public Bridleway No 4, at a point marked X, 145 metres south-east of The Hope Farm.

Part II Statement: To be prepared as follows:
As an 8.5 to 11.5 metre wide byway open to all traffic, from the C188 road, 420 metres west of Healeycote House, in a northerly direction for a distance of 230 metres, then in a general north-westerly direction for a distance of 1730 metres, to a junction with Public Bridleway No 4, 145 metres south-east of The Hope Farm.

Brinkburn **Bridleway No 1** **(NU 10 SW)**

Part I Map: The Map is not affected.

Part II Statement: To be amended as follows:
From Bridleway No 49 in the Parish of Rothbury, in a south-westerly, southerly and south-westerly direction by Lynch Wood, Woodhead Plantation and Woodhead to join Byway Open to All Traffic No 31 (the Hope - New Houses road), north-west of Throat Wood.

Brinkburn **Footpath No 2** **(NU 10 SW)**

Part I Map: The Map is not affected.

Part II Statement: To be amended as follows:
From Byway Open to All Traffic No 29 at Cockshot in a north-westerly and westerly direction by Johnson's Stile the Healey Cote - Longframlington road, Healeycote Burn, Byway Open to All Traffic No 31 (the Hope - New House road) and Bridleway No 4, to join Footpath No 48 in the Parish of Rothbury.

Brinkburn **Footpath No 3** **(NU 10 SW)**

Part I Map: The Map is not affected.

Part II Statement: To be amended as follows:
From Byway Open to All Traffic No 31 (the Hope - New Houses road) south of Throat Wood in a north-westerly, westerly, northerly and westerly direction to join Bridleway No 4 at Healey.

Brinkburn **Bridleway No 4** **(NU 00 SE)**

Part I Map: The Map is not affected.

Part II Statement: To be amended as follows:
From a junction with Byway Open to All Traffic No 32 and Footpath No 3 at Healey in a north-easterly and northerly direction crossing Footpath No 2 to join Byway Open to All Traffic No 31 (the Hope - New Houses road) south-east of Hope.

The County Council of Northumberland in exercise of their powers under section 53 of the 1981 Act, hereby confirm the foregoing Order:


