Definitive Map Modification Order (No 16) 2024

Byway Open to All Traffic No 28 (Parish of Brinkburn)

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(i), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 November 2024.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 16) 2024.

Description of Modification to Definitive Map and Statement

Former Alnwick District

Brinkburn		Byway Open to All Traffic No 28	(NZ 19 NW)
Part I	Map:	Adding thereto a byway open to all traffic, from a point marked Z, on the B6344 road, 80 metres north-east of Brinkburn High House, in a general southerly direction along the U4040 road for a distance of 1005 metres, to a point marked Y, 25 metres south-west of Middleheugh.	
Part II	Statement:	To be prepared as follows: As a 5 metre wide byway open to all traffic, from the B6344 road, 80 metres north-east of Brinkburn High House, in a southerly direction for a distance of 545 metres to the River Coquet, then continuing in a southerly direction for a further 295 metres, through the River Coquet, to a point just north of Middlehaugh, then in a general westerly direction for a distance of 75 metres, then southerly direction for a distance of 90 metres to a point 25 metres south-west of Middleheugh.


