Definitive Map Modification Order (No 18) 2024

Public Bridleway No 31 (Parish of Kirkwhelpington)

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(i), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 November 2024.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 18) 2024.

Definitive Map Modification Order (No 18) 2024

Description of Modification to Definitive Map and Statement

Former Tynedale District

Kirkwhelpington Public Bridleway No 31 (NY 98 NE)

Part I Map: Adding thereto a public bridleway, from a point marked X, on the C195 road, 180 metres south-east of East White Hill, in a general south-easterly direction for a distance of 310 metres, to a point marked T, at the existing northern end of Public Bridleway No 31, 105 metres east of Middle Whitehill.

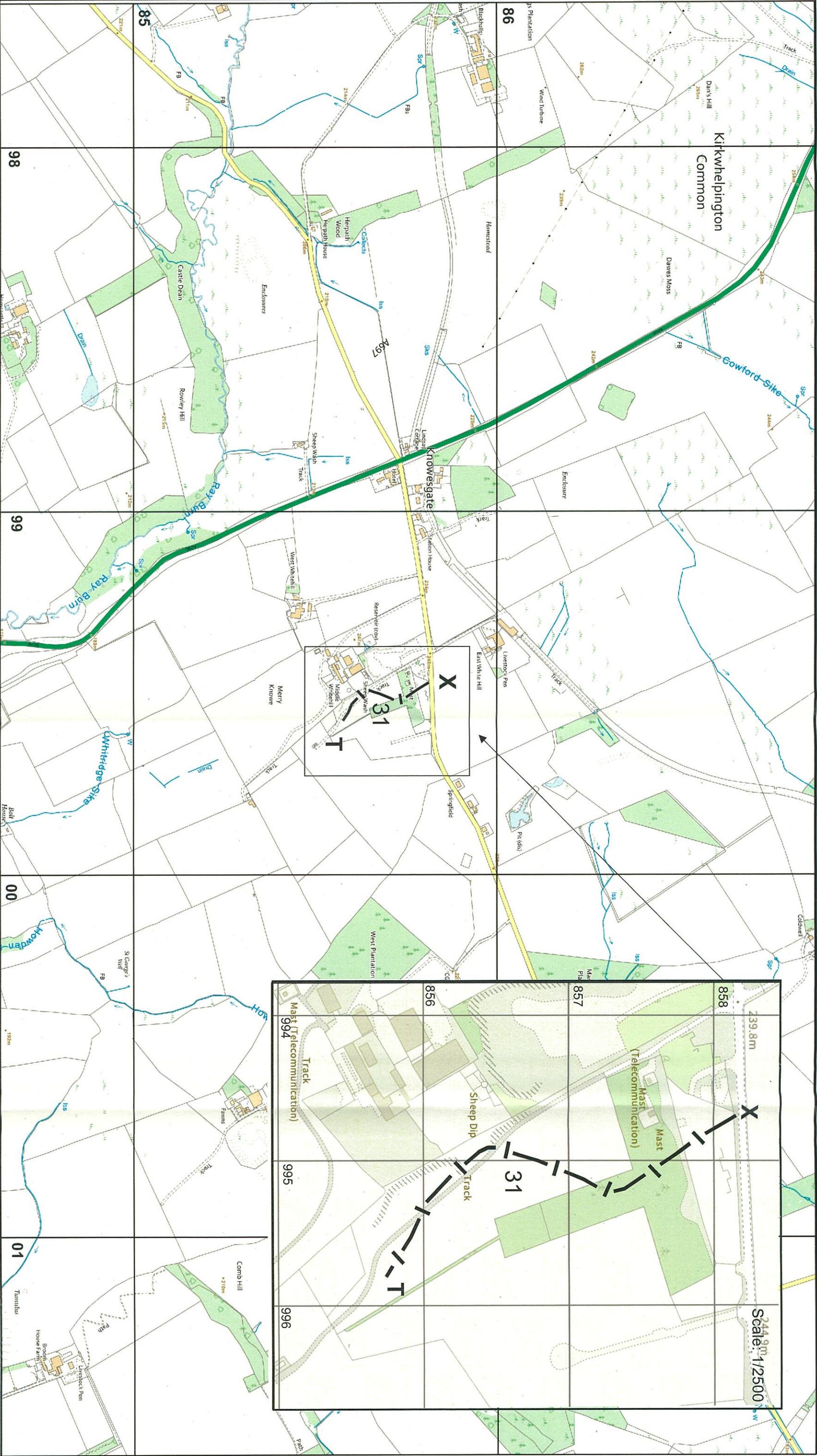
Part II Statement: To be amended as follows:
As a 3 metre wide bridleway, from the C195 road, 180 metres south-east of East White Hill, in a south-easterly direction for a distance of 90 metres, then in a southerly direction for a distance of 110 metres, then in a south-easterly direction for a distance of 110 metres, to the south end of the former quarry, 105 metres east of Middle Whitehill. Thereafter as a path in a south-easterly and southerly direction by the Spring and crossing the footbridge over the Wellburn to join the Kirkwhelpington road at the east end of Kirkwhelpington at Bolt House.

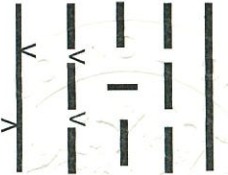
