Definitive Map Modification Order (No 19) 2024

Restricted Byways Nos 31, 32 and 33 (Parishes of Ancroft and Duddo)

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(i)(ii) and (iii), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic; and that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description; and that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 November 2024.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 19) 2024.

Ancroft		Restricted Byway No 31	(NT 94 NE / SE)
Part I	Map:	Upgrading thereto to restricted byway status, part of existing Public Footpath No 18, from a point marked P, on the C8 (Shoreswood – Ancroft) road at Longdike, in a general south-westerly direction for a distance of 1455 metres to a point marked Q, 1025 metres north-east of Ancroft Southmoor.	
	and	Adding thereto a restricted byway, from a point marked Q, on existing Public Footpath No 18, 1025 metres north-east of Ancroft Southmoor, in a general westerly direction for a distance of 1270 metres to a point marked Z, on the U21 road, 565 metres north of Ancroft Southmoor.	
Part II	Statement:	To be prepared as follows: As an 11 to 12.19 metre wide restricted byway, from the C8 (Shoreswood – Ancroft) road at Longdike, in a southerly direction for a distance of 130 metres. Thereafter as a 9.75 to 11 metre wide restricted byway in a westerly direction for a distance of 945 metres. Thereafter as a 5 metre wide restricted byway in a westerly direction for a distance of 380 metres, then northerly direction for a distance of 175 metres. Thereafter as a 12.19 to 17 metre wide restricted byway in a westerly direction for a distance of 1100 metres, to a junction with the U21 road, 565 metres north of Ancroft Southmoor.	

Ancroft**Restricted Byway No 32****(NT 94 SE)**

- Part I Map: Adding thereto a restricted byway, from a point marked Y, on the U21 road, 570 metres north of Ancroft Southmoor, in a westerly direction for a distance of 905 metres, to a point marked X on alleged Restricted Byway No 33 in the Parish of Duddo, 935 metres south-west of The Manse, Ancroft Northmoor.
- Part II Statement: To be prepared as follows:
As a 12.19 to 13.75 metre wide restricted byway, from the U21 road, 570 metres north of Ancroft Southmoor, in a westerly direction for a distance of 575 metres. Thereafter as a 5 metre wide restricted byway, continuing in a westerly direction for further 330 metres to join Restricted Byway No 33 in the Parish of Duddo, at a point 935 metres south-west of The Manse, Ancroft Northmoor.

Duddo**Restricted Byway No 33****(NT 94 SE)**

- Part I Map: Adding thereto a restricted byway, from a point marked X, on alleged Restricted Byway No 32 in the Parish of Ancroft, 935 metres south-west of The Manse, Ancroft Northmoor, in a north-westerly direction for a distance of 75 metres, to a point marked N, on the B6354 road, 920 metres south-west of The Manse, Ancroft Northmoor.
- Part II Statement: To be prepared as follows:
As a 5 metre wide restricted byway, from Restricted Byway No 32 in the Parish of Ancroft, 935 metres south-west of The Manse, Ancroft Northmoor, in a north-westerly direction for a distance of 75 metres, to join the B6354 road, 920 metres south-west of The Manse, Ancroft Northmoor.

Ancroft**Footpath No 18****(NT 94 NE / SE)**

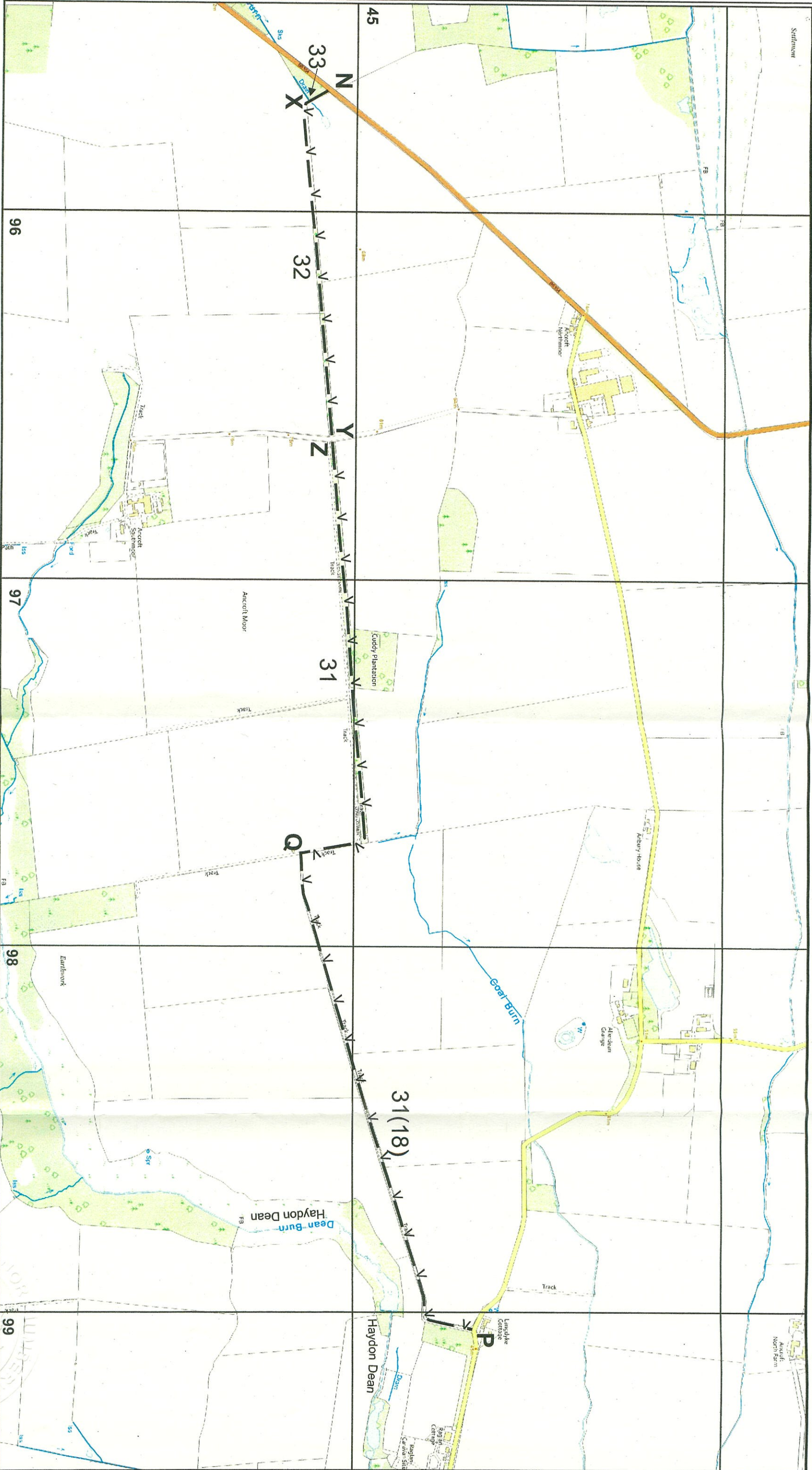
- Part I Map: Deleting thereto the public footpath, from a point marked P, on the C8 (Shoreswood – Ancroft) road at Longdike, in a general south-westerly direction for a distance of 1455 metres to a point marked Q, 1025 metres north-east of Ancroft Southmoor, as a consequence of this section being upgraded to restricted byway status (and renumbered as part of Restricted Byway No 31).
- Part II Statement: To be amended as follows:
From Restricted Byway No 31, 1025 metres north-east of Ancroft Southmoor, in a south-westerly direction by Ancroft Southmoor to join Footpath No 1 at the Kyloe Parish boundary.
