Public Footpaths Nos 24, 25, ~~26~~ & 27
(Parish of Wall)

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(i) namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 January 2022.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 2) 2022.

Description of Modification to Definitive Map and Statement

Former Tynedale District

Wall	Footpath No 24	(NY 96 NW)
Part I	Map:	Adding thereto a public footpath, from a point marked A, on the U8171 road, 230 metres north of Halfway House, in a general easterly then south-easterly direction for a distance of 420 metres, via a point marked B, to a point marked C, on Public Footpath No 18 in the Parish of Acomb, 255 metres east of East Wood House.
Part II	Statement:	To be prepared as follows: As a 1.5 metre wide footpath, from the U8171 road, 230 metres north of Halfway House, in a general easterly direction for a distance of 205 metres, through East Wood, then in a south-easterly direction for a distance of 215 metres, to join Public Footpath No 18 in the Parish of Acomb, 255 metres east of East Wood House.
Wall	Footpath No 25	(NY 96 NW)
Part I	Map:	Adding thereto a public footpath, from a point marked B, on alleged Public Footpath No 24, near the south-east corner of East Wood, 220 metres north-east of East Wood House, in a general northerly direction for a distance of 775 metres, via points marked E and G, to a point marked H, on Public Bridleway No 2, 55 metres south of Square Wood.
Part II	Statement:	To be prepared as follows: As a 1.5 metre wide footpath, from Public Footpath No 24, near the south-east corner of East Wood, 220 metres north-east of East Wood House, in a northerly direction for a distance of 450 metres inside the eastern boundary of East Wood, then exiting the wood, and continuing in a general northerly direction for a distance of 325 metres to join Public Bridleway No 2, 55 metres south of Square Wood.

Wall **Footpath No 26** **(NY 96 NW)**

Part I Map: ~~Adding thereto a public footpath, from a point marked F, on the U8171 road, 415 metres north of Halfway House, in a general north-easterly then easterly direction for a distance of 490 metres, to a point marked G, on alleged Public Footpath No 25, 480 metres west of Fallowfield Dene Cottage.~~

Part II Statement: ~~To be prepared as follows:
As a 1.5 metre wide footpath, from the U8171 road, 415 metres north of Halfway House, through East Wood, in a general north-easterly direction for a distance of 250 metres, then in a general easterly direction for a distance of 240 metres, to join Public Footpath No 25, 480 metres west of Fallowfield Dene Cottage.~~

Wall **Footpath No 27** **(NY 96 NW)**

Part I Map: Adding thereto a public footpath, from a point marked D, on the U8171 road, 275 metres north of Halfway House, through East Wood, in a general easterly direction for a distance of 290 metres, to a point marked E, on alleged Public Footpath No 25, 340 metres north-east of East Wood House.

Part II Statement: To be prepared as follows:
As a 1.5 metre wide footpath, from the U8171 road, 275 metres north of Halfway House, through East Wood, in a general easterly direction for a distance of 290 metres, to join Public Footpath No 25, 340 metres north-east of East Wood House.

Gap at point G


The specified width of 1.5 metres will be limited by the presence of established trees in places where the footpath pass within East Wood.
