Public Footpath No 200 (Former Blyth Valley Borough)

This Order is made by Northumberland County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the County of Northumberland require modification in consequence of the occurrence of events specified in Section 53(3)(c)(i), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

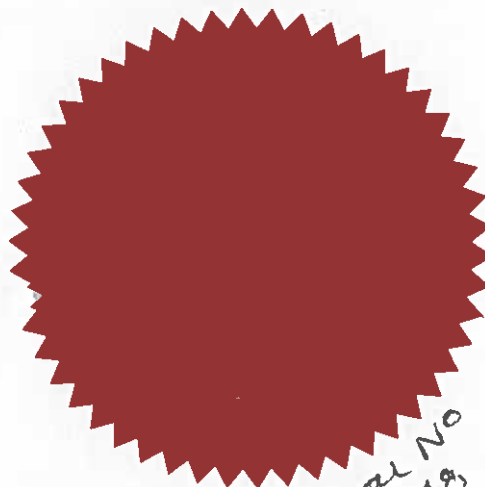
The authority has consulted every local authority whose area includes the land to which the order relates. The Northumberland County Council hereby order that:

1. For the purposes of this Order the relevant date is 1 June 2023.
2. The Definitive Map and Statement of Public Rights of Way for the County of Northumberland shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Northumberland County Council Definitive Map Modification Order (No 6) 2023.

Description of Modification to Definitive Map and Statement

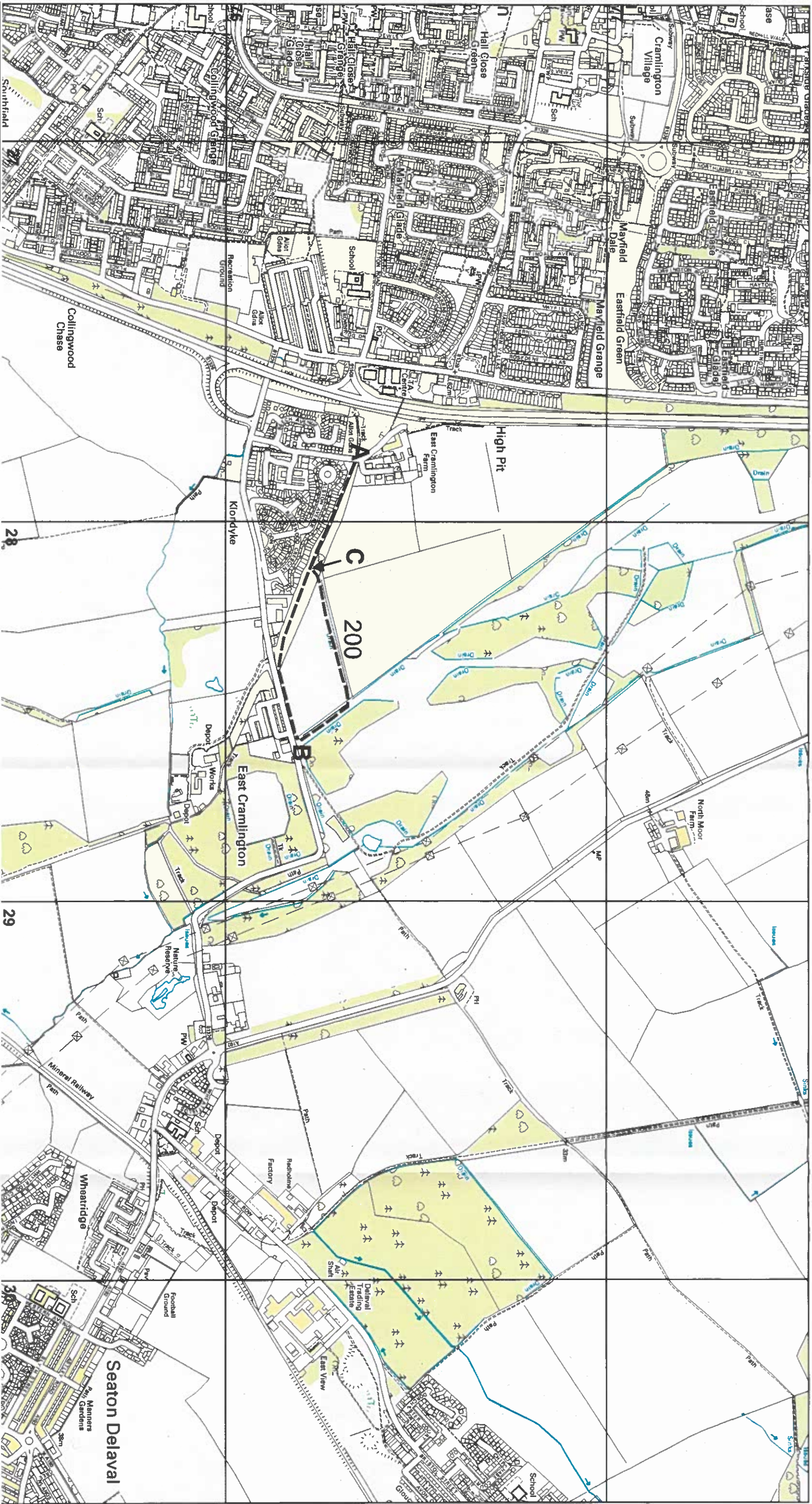
Blyth Valley	Footpath No 200	(NZ 27 NE)
Part I	Map:	Adding thereto a public footpath, from a point marked A, on the U9541 footpath, 30 metres south of number 1 The Paddock, East Cramlington, in a south-easterly, easterly, north-westerly then westerly direction for a distance of 1345 metres, via a point marked B, to a point marked C, on itself, 30 metres north-east of number 49 Reedswood Crescent.
Part II	Statement:	To be prepared as follows: As a 2 metre wide public footpath, from the U9541 footpath, 30 metres south of number 1 The Paddock, East Cramlington, in a south-easterly direction for a distance of 595 metres to a junction with the B1326 road, then in a general easterly direction for a distance of 210 metres, parallel to the B1326 road, and into East Cramlington Nature Reserve. Thereafter as a 5 metre wide footpath, in a north-westerly direction for a distance of 160 metres. Thereafter as a 2 metre wide footpath, in a westerly direction for a distance of 380 metres to join Footpath No 200 (i.e. itself), 30 metres north-east of number 49 Reedswood Crescent.

The County Council of Northumberland in exercise of their powers under section 53 of the 1981 Act, hereby confirm the foregoing Order:
