

## **Public Path Diversion Order**

### **Highways Act 1980**

#### **Northumberland County Council**

#### **Parish of Harbottle (Public Footpath No 5) Diversion Order 2024**

This Order is made by Northumberland County Council ("the Authority"), under Section 119 of the Highways Act 1980 ("the 1980 Act"), because it appears to the Authority that, in the interests of the owners of the land, it is expedient that the line of the path should be diverted.

Harbottle Parish Council has been consulted as required by Section 120(2) of the 1980 Act.

#### **BY THIS ORDER:**

1. The public right of way over the land situated at Lanternside, Holystone, and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 63 days from the date of confirmation of this Order.
2. There shall at the end of 63 days from the date of confirmation of this Order be a public footpath over the land situated at Lanternside, Holystone, and described in Part 2 of the Schedule and shown by a bold dotted and dashed line on the map contained in this order.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

## **Schedule**

### **Part 1**

#### **Description of site of existing path or way**

##### **Public Footpath No 5 (Parish of Harbottle)**

From a point marked A, in North Wood, 260 metres north of Lanternside House, in a general south-westerly then south-easterly then southerly direction for a distance of 420 metres, via a point marked B, to a point marked D, 30 metres east of Lanternside Farm.

### **Part 2**

#### **Description of site of new path or way**

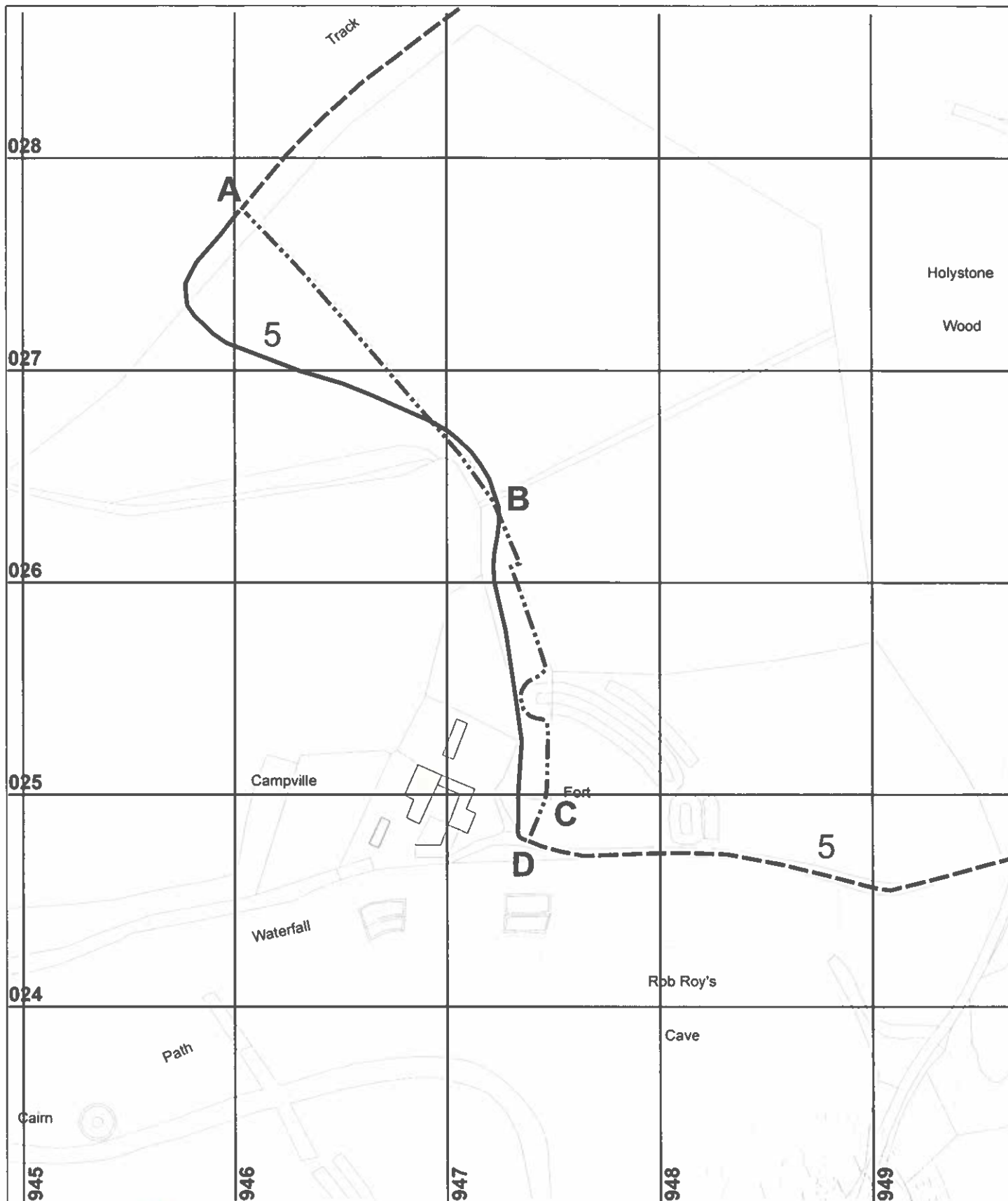
##### **Public Footpath No 5 (Parish of Harbottle)**

Creating a 2 metre wide footpath, from a point marked A, in North Wood, 260 metres north of Lanternside House, in a south-easterly direction for a distance of 180 metres, to a point marked B, then in a general southerly direction for a distance of 190 metres, skirting around the ancient monument, and via a point marked C, to a point marked D, 30 metres east of Lanternside Farm.

### **Part 3**

#### **Limitations and Conditions**

3 pedestrian wicket gates, to comply with British Standard 5709 (2018), situated at grid references NT 9461 0276, NT 9473 0260 and NT 9474 0249.
