The Northumberland County Council (Coquet Classic Mountain Bike Trial 2025) Temporary Traffic Regulation Order 2025

Road Traffic Regulation Act 1984, section 16A

Whereas:

- (1) Northumberland County Council ("*the Council*") is the local traffic authority for the purposes of Part II of the Road Traffic Regulation Act 1984 ("*the Act*").
- (2) In accordance with its powers under section 16A of the Act, the Council is satisfied that traffic on **the Parish of Rothbury Public Bridleway No. 29 from the junction with the Parish of Rothbury Public Footpath No. 25, 65 metres north-east of Featherwood in a north-easterly direction for a distance of 260 metres to a point at the junction with the Parish of Rothbury Public Footpath No. 22, 165 metres north-west of Addycombe** ("*the Road*") should be restricted for the purposes of facilitating the holding of **Coquet Classic Mountain Bike Trial 2025** ("*the Event*").

The Council hereby makes the following Order:

- 1 The use of the Road, or any part of it, as shown by a black line on the plan attached to this Order ("*the Plan*") is hereby temporarily restricted so that the Road may not be used and will be closed to access and egress **except** as provided for in paragraph 2 below.
- 2 Nothing in this Order shall apply to:
 - (a) Any activities taking place on the Road related to the organisation and holding of the Event;
 - (b) Anything done with the permission of, or at the direction of, a police officer or a Duly Authorised Officer of the Council;
 - (c) Any vehicle being used by, or for the purposes of, the emergency services;
 - (d) Any vehicle being used by or for the purposes of a statutory undertaker (e.g., the loss of supplies of gas, electricity or water to premises in the area, which requires vehicles to be brought onto the Road); or
 - (e) Pedestrian access to any premises adjoining the Road.
- 3 There will be no alternative route available for the duration of the Order.

- 3 This Order may be cited as the **Northumberland County Council (Coquet Classic Mountain Bike Trial 2025) Temporary Traffic Regulation Order 2025**.
- 4 The Order shall come into force at 12:30 hours on the 23rd August 2025 and will remain in force until 18:00 hours on the 23rd August 2025, subject to the provisions of section 16B of the Act.

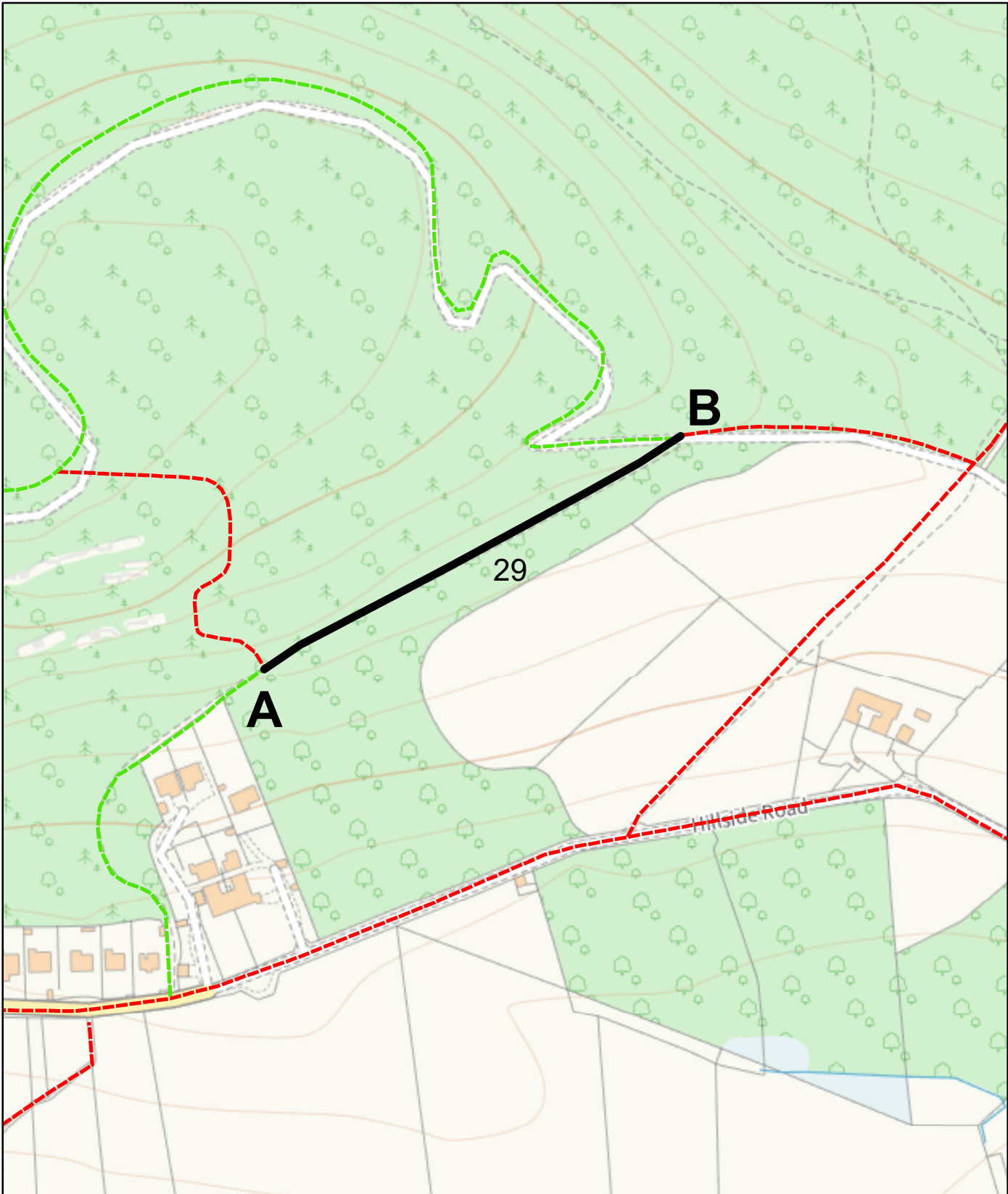
