TEMPORARY TRAFFIC REGULATION ORDER 2025  
ROAD TRAFFIC REGULATION ACT 1984 - SECTION 16A**

**NOTICE IS HEREBY GIVEN** that **Northumberland County Council** (*"the Council"*), in exercise of its powers as the local traffic authority under section 16A of the Road Traffic Regulation Act 1984 (*"the Act"*) and all other enabling powers, has on the 12<sup>th</sup> March 2025 made the **Northumberland County Council (Kielder Carlisle Stages Rally 2025) Temporary Traffic Regulation Order 2025** (*"the TTRO"*).

The Council has made the TTRO for the purposes of facilitating the holding of **Kielder Carlisle Stages Rally 2025** (*"the Event"*) by restricting traffic on **Parish of Kielder Public Bridleway No.8** from a point marked **A** immediately west of the Buck Burn, south-west of Buck Fell in a general easterly direction for a distance of 2,680 metres along Bloody Bush Road to a point marked **B**, 210 metres east of Akenshawburn and **Parishes of Greystead Public Bridleway No.23** and **Public Footpath No.15** from a point marked **C** south-east of Clock's Cleugh, 300 metres north of the Chirdon Burn in a general easterly direction for a distance of 3,595 metres via a point marked **D** to a point marked **E** on **Public Bridleway No.21** at Chirdon Head and **Parish of Greystead Public Bridleway No.3** from a point marked **F**, 420 metres south-east of Ridge End in a general south-easterly direction for a distance of 2,875 metres to a point marked **G** east of Bower (*"the Road"*).

The TTRO shall come into force at **7:00 hours** on the **12<sup>th</sup> April 2025** and will remain in force until **21:00 hours** on the **12<sup>th</sup> April 2025**, subject to the provisions of section 16B of the Act.

There will be no alternative route available for the duration of the TTRO.

All restrictions on the Road will be sign-posted and staffed and will remain in force only for as long as is necessary.

Nothing in the TTRO shall apply to:

- a. Any activities taking place on the Road related to the organisation and holding of the Event;
- b. Anything done with the permission of, or at the direction of, a police officer or a Duly Authorised Officer of the Council.
- c. Any vehicle being used by, or for the purposes of, the emergency services;
- d. Any vehicle being used by or for the purposes of a statutory undertaker (e.g. the loss of supplies of gas, electricity or water to premises in the area, which requires vehicles to be brought onto the Road); or
- e. Pedestrian access to any premises adjoining the Road.
