## **Definitive Map Modification Order (No 15) 2024**

The above Order, made on 13<sup>th</sup> November 2024, if confirmed as made, will modify the definitive map and statement for the area by:-

# Former Tynedale District Restricted Byway / FP No 27 & FP 26 (Parish of Greenhead)

Upgrading thereto to restricted byway status (and renumbering as part of Restricted Byway No 27), part of existing Public Footpath No 26, from the U7036 road, 65 metres south of Benkshill (O.S. Grid Ref NY 7103 6908), in a general north-easterly direction for a distance of 1120 metres to the junction between existing Public Footpaths Nos 26 and 27, 435 metres north-east of Wall Shield (NY 7143 7001).

And upgrading thereto to restricted byway status, all of existing Public Footpath No 27, from the path's existing junction with Footpath No 26, 435 metres north-east of Wall Shield (O.S. Grid Ref NY 7143 7001), in a general easterly direction for a distance of 370 metres, to join alleged Restricted Byway No 1 in the Parish of Melkridge, 750 metres north-east of Wall Shield (NY 7177 7014).

### Restricted Byway / FP No 1 (Parish of Melkridge)

Upgrading thereto to restricted byway status, all of existing Public Footpath No 1, from alleged Restricted Byway No 27 in the Parish of Greenhead, 750 metres north-east of Wall Shield (O.S. Grid Ref NY 7177 7014), in a general north-easterly direction for a distance of 730 metres, to join the U7041 (Edges Green – Grindon Green) road, 210 metres west of Slippy Stones (NY 7237 7052).
