## NORTHUMBERLAND COUNTY COUNCIL (Tyneside Stages Rally 2022) TEMPORARY TRAFFIC REGULATION ORDER 2022 ROAD TRAFFIC REGULATION ACT 1984 - SECTION 16A

**NOTICE IS HEREBY GIVEN** that **Northumberland County Council** (*"the Council"*), in exercise of its powers as the local traffic authority under section 16A of the Road Traffic Regulation Act 1984 (*"the Act"*) and all other enabling powers, has made on the 20<sup>th</sup> July 2022 the **Northumberland County Council (Tyneside Stages Rally 2022) Temporary Traffic Regulation Order 2022** (*"the TTRO"*).

The Council has made the TTRO for the purposes of facilitating the holding of the **Tyneside Stages Rally 2022** (*"the Event"*) by restricting traffic on the Parish of Alwinton Public Bridleways Nos 23, 39 & 44 and Restricted Byway Number 58 from a point marked A north of Thirl Moor via Featherwood, Bushman's Crag, Cocklaw Green and Davysiel to a point marked B at Leighton Hill, the Parish of Harbottle Public Bridleway No 8 from a point marked C west of Rochester to a point marked D east of Cottonshope Head, the Parish of Hepple Public Bridleways Nos 15, 20 and Restricted Byway No 32 from a point marked E at Cocklaw Green to a point marked F north of North Yardhope, the Parish of Otterburn Public Footpath No 44 and Public Bridleways Nos 1, 2 & 3 from a point marked G on Holystone Common to a point marked H at High Carrick and the Parish of Rochester Public Footpath No 18 and Public Bridleways Nos 6, 7, 8, 26, 27 & 28 from a point marked J south of Cocklaw Green via a point marked L north of Stewart Shiels to a point marked K north-east of Stewart Shiels (*"the Road"*).

The TTRO shall come into force at **1:00 hours** on **7<sup>th</sup> August 2022** and will remain in force until **23:55 hours** on **7<sup>th</sup> August 2022**, subject to the provisions of section 16B of the Act.

There will be no alternative route available for the duration of the TTRO

All restrictions on the Road will be sign-posted and staffed and will remain in force only for as long as is necessary.

Nothing in the TTRO shall apply to:

- Any activities taking place on the Road related to the organisation and holding of the Event;
- Anything done with the permission of, or at the direction of, a police officer or a Duly Authorised Officer of the Council.
- Any vehicle being used by, or for the purposes of, the emergency services;
- Any vehicle being used by or for the purposes of a statutory undertaker (e.g. the loss of supplies of gas, electricity or water to premises in the area, which requires vehicles to be brought onto the Road); or
- Pedestrian access to any premises adjoining the Road.
