Definition of Resident/Non Resident

Resident fees & charges apply to anyone permanently residing within the boundaries of the county at the time of their death e.g. in their home or in a residential/nursing home. Non Resident fees & charges apply to anyone who wanted to be buried or cremated in a County Council premises but who, at the time of their death was living at a permanent address external to the County boundaries. The Head of Neighbourhood Services has the authority to apply discretion when necessary in cases that do not fit easily into the above case
