## FIREWORKS ACT 2003. FIREWORKS REGULATIONS 2004.

### APPLICATION FOR A LICENCE TO SUPPLY OR EXPOSE FOR SUPPLY ADULT FIREWORKS IN ACCORDANCE WITH REGULATION 9 FIREWORKS REGULATIONS 2004

The supply or exposure for supply of any adult firework without an appropriate licence issued by the local licensing authority represents an offence contrary to section 11 of the Fireworks Act 2003. This prohibition does not apply to the supply of adult fireworks:

1. On the first day of the Chinese New Year and the three days immediately preceding it.
2. On the day of Diwali and the three days immediately preceding it.
3. During the period beginning on the 15<sup>th</sup> October and ending on the 10<sup>th</sup> November.
4. During the period beginning on the 26<sup>th</sup> December and ending on the 31<sup>st</sup> December.

Northumberland County Council may refuse to grant a licence, or may revoke a licence which it has granted, if the applicant has committed:

- An offence under section 11 of the Fireworks Act 2003.
- An offence under section 12 of the Consumer Protection Act 1987 arising from a contravention of the Fireworks (Safety) Regulations 1997.
- An offence under sections 4, 5 or 32 of the Explosives Act 1875.
- An offence in relation to the use, storage or keeping of fireworks under the Health and Safety at Work Act 1974.
