5. Programme Officers Report to include Project Expenditure to Date:

IH - Gave Programme Officers Report and informed LAG of current project budget commitments and spend. Asked that LAG agree to consider project applications on the basis of those figures

As of 17th January 2018 LAG has committed £881,489.69 with a balance of £746,046.31 remaining to commit.

Note - LAG approved and agreed Budget profile

IH - informed LAG meeting that they have a small number of Full Applications that will not progress for LAG decision. FA Applicants will be formally notified of withdrawal. Shoreside Shepherd Huts FA - IH received email outlining the progress of this application and confirmation that project will go ahead in spring 2018 and be complete by end of May

IH - Asked LAG to progress project on projects timescale

SC - A May deadline is quite late

AW - Asked LAG members to agree to Programme Officers proposal

a. LEADER Programme 2014 - 2020:

DB - Process could get competitive due to limited allocation

SC - Again the time scales will play a mayor part

DB - We're still working towards final claims in December 2018 with full programme closure end of March 2019. Rumours circulating from RPA, other programmes are being extending but nothing about LEADER as yet, conversations are ongoing. A request has been made to increase RC&A Budget from 18% up to 25% to allow for programme extension, but there would still be issues around deliverability. Realism of applications, look at EOIs deliverability and risk, planning consents etc., all has a knock on effect.

The accountable body looks at risk assessment for each case to help with LAGs decision. LAGs have to decide priorities going forward. C&L have done well on their job forecast. Any significant change in priorities will flag up with the RPA. LAG and AB will keep an eye on budget and identify 70/30 split

AW - The Operation Group Meetings held bimonthly and attended by David Baird (Accountable Body), Ross, Chair and Alex, Vice Chair on behalf of the LAG, and LEADER staff is a good time to discuss DB's update and bring back focus to discuss with LAG members

Grant is also sought to undertake groundworks, electricity installation, waste services and to project manage the process. The project will tap into the growth of 'glamping' will cater for tourists to coastal Northumberland.
