#### **SEND** update

The Virtual School's acting Deputy Head, Tara Prescott, fulfils the role of the Virtual School SENDCO. A key part of this role is oversight of a multi-agency action plan following a themed audit which took place last year to find out *what it's like to be a looked after child with SEND in Northumberland*.

To deliver on the action plan we are working with health and social care partners to make improvements in 4 themed areas identified by the audit:

- 1. Looked after children with SEND are recognised as a priority group
- 2. Timeliness of decision making
- 3. Voice of the child
- 4. Information sharing

The Written Statement of Action (WSoA) which was put in place after the Ofsted Local Area SEND inspection in 2018 has an action to **align looked after and EHCP reviews**. Your SEND support officers and IROs have been working with you on this and the Virtual School is there to facilitate, communicate and advocate if we need to. Get in touch if you want further advice and support.

There is a new post in the SEND Assessment and Monitoring Team, funded by the Virtual School, of **SEN Lead Officer for Looked After Children**. Recruitment is underway and we hope that the successful candidate will be in post very soon.

In January the local authority experienced an **SEND Peer Review**. The outcomes from the review will be shared with us in due course.

## **Pupil Premium Plus for Looked After Children 2021-22**



There will be no change to Northumberland's arrangements for dispersing the Pupil Premium Plus for looked after children in the new financial year, starting 1<sup>st</sup> April 2021. Just a reminder that your termly PP+ payment is dependent on you having submitted a review of the Outcomes section of each looked after child's ePEP. If you haven't already submitted the Outcomes section for Autumn 2020 then it isn't too late, but please hurry as there isn't much time left in the current financial year. ## Termly progress reviews

Progress reviews for each looked after child are due termly. You get a message to say that it is due and submit the completed form through the ePEP.

If there are blank fields in the form then it won't send, so please make sure there is something in every box. Don't worry about saying homework has been set if it hasn't been during lockdown.

Our ePEP developer is busy creating a form in the ePEP for you submit weekly attendance data for looked after children. It will mean no separate piece of paper or nagging phone calls and emails to follow up requests!

More information will follow, but we know that persistent absence amongst our looked after children is increasing and not necessarily related to Covid 19. When the return to school is complete we will be targeting children to improve their attendance rapidly, and will be asking for your help as DTs to achieve that.
