Our virtual Virtual School training programme for 2020-21 is underway. You will be invited to all of our conferences, and can book a place on our other courses using this <u>Microsoft form</u>

There are two new training modules on the virtual platform Learning Together which you and your school staff will find useful and informative when working with looked after children and care leavers. Both modules were developed in-house and have a Northumberland context:

The Education of Looked After and Previously Looked After Children which is for all professionals who have an interest in care experienced children doing the very best they can at school. The course develops important learning about statutory requirements as well as improving knowledge and understanding about:

- the education needs of looked after children and the challenges they might have to overcome to enjoy success
- what the Virtual School is
- what a Designated Teacher for looked after and previously looked after children does
- corporate parenting
- what works when intervening to support the education of looked after children
- the support available to children and schools and how to access it.

Reducing Criminalisation of Looked After Children which will help you to understand the purpose and process of the of the Protocol for Reducing the Criminalisation of Looked After Children and Careleavers. You will learn about:

- who looked after children and care leavers are
- recognise the impact of trauma on the behaviour of these young people
- identify the key elements of Northumberland's Protocol

recognise the difference this protocol can make in children's lives

Both courses are highly recommended by Northumberland's Virtual School Headteacher so please add it to your list of must-do training, it will only take you 30 minutes to complete!

School placement stability

The return to school for many looked after children has been positive. Thank you for preparing so carefully for the new term and for making the school environment safe and welcoming for our pupils.

Some looked after children continue to experience difficulties with their new school environments and are not coping well with the changes. Please keep in close contact with us about children who are in need of extra support.



Through the ESLAC team we can provide expertise from teachers, Educational Psychologists, therapeutic intervention workers, education welfare and careers' guidance.

We can also facilitate integrated working with foster carers, SEND, CYPS, SALT, NIES and Northumberland Adolescent Services.

Northumberland ePEP user guide

The Northumberland ePEP is well and truly at the centre of our support for children, helping them all to do the best they can at school. Please take a look at the new <u>Northumberland user guide</u> which takes you step by step through the PEP process. More of this at the Autumn conference too!

Remember that the **Pupil Premium Plus** will be allocated this term according to the policy, which requires Designated Teachers to have reviewed outcomes by the end of term and if it is due, to have hosted a 6 monthly PEP review.

Next half term you will also receive an electronic request through the ePEP to submit each child's progress review.
