Safeguarding in the Holidays – Some Reminders

- Please make arrangements for passing child protection information to new schools where required



 KCSiE says that it is up to individual schools to arrange cover with DSLs over the summer holiday:

"It is a matter for individual schools and colleges and the designated safeguarding lead to arrange adequate and appropriate cover arrangements for any out of hours/out of term activities."

- Encompass and Endeavour notifications will continue to be emailed to the two named contacts.
- You will still receive invites to any Children's Services meetings taking place. You do not have to attend however, your input is important as decisions may be made about closing cases.
- Many of you have previously shared mobile numbers with us, and we would only ever use these in emergencies. If we have any queries we will normally send you an email over the break.
- **Please**, let us know if there are changes to your safeguarding team. It is important emails are not sent to the wrong people

July and September are times of transition for many staff, as well as for lots of our children, so this is a plea to any colleagues who are moving on to new posts. If you are moving on to a new role, a new school, or retiring from your role as DSL, could you please let us know so we can update our contact list.

This is especially important if you are the named person for Operation Encompass and Operation Endevour notifications. It would be awful if these notifications were sitting in the inbox of emails that are no longer active, it would mean that vulnerable children and young people are not getting the support they need.

As well as letting us know that you are leaving, could you please send us the email address and contact details of the person who is taking over your role as DSL so we know who your replacement is and we can contact them if we need to.

- Safeguarding processes, procedures and protocols must be part of the induction programme for all new staff at your setting
