### Ofsted new inspection framework: consultation

Ofsted has launched a consultation about the new Inspection framework to be in place from September 2019.

From a safeguarding perspective, there are no real changes in this proposal. The framework is clear that inspectors must **evaluate the safeguarding culture that has been established in the school**, and not simply review documents. Ofsted define safeguarding as being ineffective when 'there are serious or widespread failures in the school's/setting's safeguarding arrangements that give cause for concern because children are not protected and statutory requirements are not being met, or because insufficient action is being taken to remedy weaknesses following a serious failure of safeguarding arrangements.'

In the draft guidance the section on safeguarding is on pages 67/68. This consultation closes at **11:45pm on 5 April 2019**.

## In brief

### Infographic: Screen-based activities

## News of pilot project with schools

From this month a pilot project is starting with Prudhoe High School, the Data Unit and children's social care. The school will receive monthly information from the Data Unit about the active early help and/or social care status of its pupils, including those which have changed their status during the previous month. Active cases include those **with Early Help involvement (an Early Help Assessment), children in need, child protection and looked after children**. It is hoped that if successful that the pilot will be rolled out across all Northumberland schools.

## Operation Encompass: the next steps

A new collaboration between Northumbria Police, the Office of the Police and Crimes Commissioner, Operation Encompass and Barnardos has been developed and is ready to be launched. It's called **'Operation Encompass: The Next Steps'**. This is a pilot across Northumbria intended for national roll out.

This collaboration aims to build on successes so far, to provide enhanced support to children, families and staff affected by domestic abuse. Schools involved will be supported to raise awareness of healthy relationships and enable appropriate support and safeguarding within the safe school environment.

The main elements of the project will include training for ALL school staff to achieve a whole school approach, development of PSHE products for Key Stages 1-4, a drop in/advice service at schools and access to new school safeguarding liaison officers (SSLOs) employed by the Northumbria Police.

Head Teachers will be briefed on the new developments at the Director of Education briefings in March and this will be followed by briefings of key adults. We hope that the key adults for Operation Encompass and/or PSHE leads will be able to attend these briefings and invites will be sent to all key adults shortly.
