

NSCB Multi-Agency Training Annual Report 2018-19

During 2018-19, there was a broad multi-agency training offer available to NSCB partner organisations. This included the scheduled programme and a number of additional events which were developed in response to emerging local, regional and national issues and serious case reviews.

There has been a particular focus on reviewing the training offer around domestic abuse with the development of regional learning packages by the Office of the Police and Crime Commissioner (OPCC). There was also a series of successful workshops developed and delivered specifically as part of Domestic Abuse Awareness Week.

Key learning from multi-agency case reviews and NSCB case audits have been embedded into training quickly. In response to unmet demand, an additional carousel event was provided, sharing learning from the 'Kirsty', 'Natalie', Molly' and 'Olivia' serious case reviews and there were learning events around the County addressing the learning from Operation Sanctuary and the 'Sarah' DHR.

To support the NSCB priority related to Early Help and Prevention, a second multi-agency training programme has been provided to complement and support the safeguarding training offer. This brings together some existing training (eg Introduction to Early Help) with many new learning events relating to emotional health and wellbeing, including tools and techniques for working with children and families. (Details and data relating to the Early Help and Prevention programme are not included in the main body of this report, but are outlined in Appendix 1).

The multi-agency programme continues to be predominantly facilitated by staff from partner organisations, with only three topics being commissioned from external providers

- Signs of Safety
- Children who Display Sexually Harmful Behaviour
- Working with Uncooperative and Resistant Families.

The skill, knowledge and professionalism of the trainers is regularly praised by delegates:

"The person doing the course was very knowledgeable and had a good understanding of the area.

Very open and honest course"

"Fantastic and knowledgeable course - thank you. My support for children and families will be a lot more thorough because of the learning experience of this course".

"Clear delivery of the topic, excellent presentation and good activities to reinforce the learning".

"My knowledge and understanding of attachment and ACEs has been greatly enhanced (again). I have thoroughly enjoyed these 2 days and delivery of the course was engaging and kept me focused. The chance for professional dialogue was invaluable. I am leaving enthused about ways to support pupils further in the schools I work with. Thank you."

Attendees also frequently comment on the benefit of training in a multi-agency group where knowledge is shared by delegates as well as trainers:

"It has really helped to listen to professionals on the ground - this aspect makes the knowledge concrete."

Training is regularly updated in light of new statistical information, local and national learning, recent case reviews and audits and current research findings. The Policy, Procedure and Training Sub-Committee has a rolling programme of course review to ensure compliance with NSCB's quality standards for training and local policies and procedures.

Over 2018-19, the multi-agency training offer has developed flexibly in response to local need with the following learning events being provided in addition to the initial training schedule:

- Training for Trainers in Safeguarding Children for VoiCeS to build capacity for VCS training
- Additional SCR Carousel Event to address waiting list from 2018-19 offer
- 8 Operation Sanctuary/Sarah DHR events
- Additional E-Safety session provided by Northumbria Police
- Working with Perpetrators of Domestic Violence and Abuse provided by CRC
- MARAC Training for Trainers in response to updated process
- 3 Domestic Abuse Awareness Week Workshops

There was a particularly high demand for places at the Working with Perpetrators of Domestic Violence and Abuse course with many applicants being disappointed not to get a place at the training. Unfortunately CRC were not able to offer any additional sessions.

Over 90% of the training is provided as 'goods in kind' by NSCB partner organisations. However the infrastructure supporting the training is wholly funded by Northumberland County Council. This includes:

- Salary of Learning and Development Coordinator
- Administration of the programme (including help desk support)
- Production of learning materials
- Venue hire and refreshment costs
- Provision and management of learning platform 'Learning Together' for application process
- E-learning provision
- Funding of training commissioned from external providers (eg Signs of Safety)

The 'profit' generated by the NSCB charging policy and training commissioned from the training coordinator has been used to fund the venue costs for the new Early Help and

Prevention programme. Across the two training programmes we have an almost balanced budget between income and expenditure.

It should be noted that the £6,000 income for mental health training was unique to this year and will not be replicated in the next financial year. However it is hoped that implementing the non-attendance charging policy for multi-agency Early Help and Prevention training will go some way to underwriting the costs of the Early Help programme in future.

(Local Authority) Designated Officer Training

The Designated Officer delivered 23 training events on the LADO Role and Safe Working Practice. The sessions ranged in size from large events/conferences for schools, to small group events for specific teams. The total attendance at these learning events was 833.

Bespoke Training for Partner Organisations

The Learning and Development Coordinator for the NSCB programme has also supported single agency safeguarding training by providing bespoke sessions on child protection and related topics for the following partner organisations:

- Northumbria National Park Authority
- Northumbria Police
- Charlotte Straker Homes
- Early Year Settings
- Northumberland College
- 3 schools

The NSCB Business Manager also delivered bespoke training on safeguarding and County Lines for Northumberland Community Service Volunteers (CSV).

Schools' Training

NCC's Education Directorate offers a Safeguarding Service Level Agreement to Northumberland schools and education providers. This includes Designated Safeguarding Lead and basic whole-school training. For those schools who do not buy into the SLA, training can be purchased from the Schools' Safeguarding Team using the same pricing structure as NSCB training.

During 2018-19, the Schools' Safeguarding Team delivered training as follows:

- 1,500 attended whole school safeguarding training
- 105 delegates attended New DSL training
- 178 delegates attended DSL Refresher training
- 200 school staff received Operation Encompass training

Early Years Training

NCC's Early Years Team provide safeguarding training specifically for daycare settings. During 2918-19 they delivered the following:

- 3 Introduction to Child Protection courses (48 delegates)
- 2 Child Protection Refresher courses (34 delegates)
- 3 DSL New to the Role courses (59 delegates)
- 3 DSL Refresher courses (73 delegates)
- 2 Decision Making in Child Protection courses (52 delegates)

Appendix 1 Early Help and Prevention Multi-Agency Training Annual Report 2018-2019

Background and Context

This has been the first full year of the Early Help and Prevention Multi-Agency Training Programme. Some of the courses in the programme were already offered by individual teams, but these have been brought together under one coordinated offer and supplemented by many new learning opportunities for the children and families workforce across Northumberland.

The training programme sits within the Northumberland Safeguarding Children Board for its governance arrangements and quality assurance. It is based on the principle that all courses are facilitated by staff from partner organisations who share their specialist knowledge and expertise with training teams often being multi-agency or multi-disciplinary.

Attendance at all courses is free of charge to anyone working with children or families in Northumberland. Charges are incurred for non-attendance without prior cancellation.

The training programme is structured in three sections:

- 1. Early Help process
- 2. Tools and techniques
- 3. Issue-based training

The issue-based learning events have a particular focus around emotional wellbeing, mental health and resilience in line with Northumberland's Resilience Strategy and the Mental Health in Schools trailblazer.

This first year of the training offer has seen some significant success with courses being well-attended and, in some cases, significantly over-subscribed. The initial training brochure, circulated in April 2018, has been supplemented with two further catalogues as the training offer developed over the year.

Expenditure

Trainer time and expertise is given as 'goods in kind' by partner organisations and therefore the only costs are administration of the programme (provided by NCC) and expenditure on venues which has totalled £3,200. This spending has been funded from income generated by the NSCB programme's charging policy for attendance and non-attendance. Trainers are expected to provide their own materials and resources for the courses they facilitate.

Feedback on Training

Post-course evaluation on each course demonstrates a high level of appreciation for the quality and relevance of the training across the whole programme. In addition to this we have had a number of emails providing 'unsolicited' feedback on the programme as a whole, but also providing positive feedback on specific courses, eg:
