

### Council Tax - Carer's Discount

If there is someone in your house who provides care you may be entitled to a discount depending on who else lives in the property. Carer's are a category of person disregarded from the calculation of Council Tax. If all residents are disregarded then the Council Tax is charged at 50%. If all but one person are disregarded a discount of 25% applies.

To qualify the person receiving care should be receiving one of the qualifying state benefits (see enclosed). They should live in the same property as the care provider and the care provider should be providing care for at least 35 hours per week.

This discount will not apply where the person providing care is the spouse/partner of the person receiving care. It will also not apply if they are the parent of the person receiving care and that child is under 18 years of age.

All applications should be accompanied by evidence that the qualifying state benefit is being received. This is usually a letter from the DWP, but other forms of proof are acceptable.
