- Applications, amendments or cancellations of postal votes must reach the relevant Electoral Registration Officer by 5pm on Wednesday 17 April 2024. Applications can be made online at gov.uk/apply-postal-vote.
- 8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election **must** reach the relevant Electoral Registration Officer by **5pm** on **Wednesday 24 April 2024**. Applications for a Voter Authority Certificate can be made online at **voter-authority-certificate.service.gov.uk**.
- 9. Applications to vote by proxy at this election **must** reach the relevant Electoral Registration Officer by **5pm** on **Wednesday 24 April 2024**. Some applications can be made online at **gov.uk/apply-proxy-vote**.
- 10. Applications to vote by emergency proxy at this election **must** reach the relevant Electoral Registration Officer by **5pm** on **Thursday 2 May 2024**.
