Vision for the Town

The board was asked to consider the elements that might be incorporated into a Borderlands Place Plan Vision for the town. They were reminded of the Borderlands overall programme core principles when they did this:

The five core principles that underpin the Place Programme:



- Place-based: Assessing investment needs and solutions for each place on its own terms: what the place wants to be in the future, what it needs, and what it offers.
- Collective: Looking at the contribution of each part to the whole: the added value to the place, the area, the region, and the country.
- Systemic: Bringing public, private, third sector, and community assets together as part of a single, integrated system supporting communities, services and the economy.
- Community-led: Putting communities at the heart of decisions about the solutions that the Place Programme brings to the challenges facing their towns and town centres.
- Prevention and future proofing: Investment and action directed towards preventing further deterioration in our towns and town centres.

The group used time in the previous meeting to brainstorm ideas. These are summarised below:

- Allowing young people to stay in the area not priced out
- Higher education and apprenticeships provision
- No vision of high school education
- Affordable living for young people outside of area
- Large-scale tourism accommodation
- Year-round economy seasonality
- Ability to engage the community esp. Youth
- Encourage coach trips to use local facilities through accommodation
- Management of visitor numbers/tourism
- Ongoing work to ensure the support remains
- Encourage coach trips to use local facilities through accommodation
- Ongoing revenue costs for Cragside balance costs
- Infrastructure
- Improved public transport
- Cycling & walking routes
- No regular bus service to Cragside please note that this how now been amended to demonstrate that the issue for residents was the lack of access/public footpath to an alternative entrance. The alternative entrance is not an official entry point to the Cragside estate.
- Access routes by more accessible roads & paths
- Not enough infrastructure for visitors



- Improved parking facilities
- Hubs would encourage businesses to stay or come to the area
- Lack of facilities to encourage and keep people here
- Support for small businesses
- Youth provision, sports facilities and affordable housing
- Impossible to get on property ladder
- Unbalanced labour market due to lack of affordable housing
- Lack of good social care for the elderly
- Assisted housing needs/elderly



The NCC Officer group used these ideas to draft the following proposed Borderlands Place Programme Vision for the town. This was then reviewed by the board and amendments made as demonstrated in the second text box. The word 'sustainable' was added to prefix 'environment' and 'both now and for the future' added to the final line.



Original (drafted) Borderlands Place Programme Vision:

"Collaborating with the community of Rothbury to create the environment, facilities and infrastructure to support residents, businesses and visitors of the town."

Revised Borderlands Place Programme Vision:

"Collaborating with the community of Rothbury to create a sustainable environment, facilities and infrastructure to support residents, businesses and visitors of the town both now and for the future"



Rothbury Borderlands Place Programme Strategic Objectives

The board was asked to consider the overall Borderlands Place Programme. The Programme has seven investment objectives, focused on addressing regionally identified challenges and opportunities:

- SO1: Empower local communities to imagine and then build a long-term future for the towns they live in.
- SO2: Safeguard existing businesses and attract new businesses to our towns and town centres.
- SO3: Maintain and increase the number of visitors spending money in our towns and town centres.
- SO4: Safeguard existing employment and deliver new jobs and opportunities for economic and social participation.
- SO5: Maintain and increase the number of people living in our towns and town centres.
- SO6: Retain and increase the working age population in towns.
- SO7: Maintain and raise the quality of the physical environment in our towns and town centres.

At the previous meeting, the board was asked to identify at least <u>four</u> of the above that could be tailored to suit the needs of the local community in their view. These are highlighted in <u>red</u>.

The following draft strategic objectives for the Borderlands Place Programme in the town were identified and completed by the officer team at NCC, for further consideration before community consultation.

The only change made was a final sentence in SO4 which emphasised the importance of facilities for young people.



Drafted Rothbury Borderlands Place Programme Strategic Objectives

- 1. Retain and increase the number of working age residents in Rothbury.
- Maintain and increase the number of visitors spending money in Rothbury.
- Safeguard and develop the businesses of Rothbury, ensuring a strong local employment opportunity, driving economic and social participation.
- 4. Maintain and raise the quality of the physical environment in the centre of Rothbury.

Revised Rothbury Borderlands Place Programme Strategic Objectives

- Retain and increase the number of working age residents in Rothbury.
- Maintain and increase the number of visitors spending money in Rothbury.
- Safeguard and develop the businesses of Rothbury, ensuring a strong local employment opportunity, driving economic and social participation.
- Maintain and raise the quality of the physical environment in the



Public Consultation & Citizen Space Survey

The board discussed the methods used to let the community know about the Rothbury Borderlands Place Programme. The drafted Vision and Strategic Objectives would be presented, and the community would be asked for their views on them. Similar consultations had been completed by the delivery team at NCC using online survey software Citizen Space as well as through hard copies of questionnaires in strategic locations. The aims are to:

- Ask respondents about how they feel about living / working / running a business / studying in Rothbury:
- o What are the best things?
- o What are the worst things?
- o What would you like to change?
- Gather demographic data from the respondents to ensure a representative view
