

| WT – the power supply in the Market Place did have an old supply underground but there were issues with water getting in and it didn't work so I assume that's been taken out now? CA – Advance have looked at that and the new supply will be kept above ground. | |
| Housing Renewal and Welcoming Safe Blyth – Empty Homes Team; 4 properties back into use aiming for another 26 by 2026. Bowes Court Improvement Scheme is to improve 72 properties; engagement event 30 September; pre-works assessment starting now and aiming for late spring 25 completion. Extra Care provision is developing as a proposal for 85 properties in partnership between NCC, NHS and 3 rd party registered providers. Welcoming & Safe Blyth is partly developed and on hold as it is included in the LTPFT proposals for a 'Community Fund'. Town Centre Living, Richard Stannard House is proposed to be refurbished and converted into 16 apartments for the private rental market to be owned and operated by Advance. | |

OREC – update provided by Darren Broderick, OREC on Technology Development Centre (TDC). Background; aim of project; project location; layout of facility; what TDC will do; renovation due to complete November 2024; operational early 2025.

DC – the Buffalo Centre is across the road from the TDC and a few years ago when the wind test facility was built the power in the area went out when it was turned on. Is it assured that the power will not be turned off with this facility? Darren – yes, the requirement is small for power and testing and we are conscious of being a good neighbour so part of the upgrade is looking at our side of the grid so to speak so it doesn't affect Blyth as a whole.

DC – I know the Port has put an echo in and we get complaints of seagull noise, is that coming for the TDC too? Darren – no. ML – It's meant to be birds of prey noise to reduce the seagulls, we have reduced the sound level and frequency following those complaints.

AT – ECLH thank you for the work the Team have done on developing the TDC, it's amazing to see our students there benefiting from this incredible facility. Once we're past the November 2024 renovation deadline could we meet to discuss the pathways and throughputs for learners out of TDC and into ECI so were making it easy for students to move seamlessly between the two? ML – ECC Board and staff are happy to have those discussions and also how the T levels integrate. LB – that is an important process for the ECI business case and those discussions are ongoing ready for the OBC in December.

Connected Town - LP

Bridge St Improvements – P1, P2, P3 are substantially complete; P4 expected to complete November 2024; completion spring 2025.

Quay Gateway – FBC expected October 2024; stakeholder engagement late 2024; works commence spring 2025; complete late summer 2025.

Regent St – detailed designs and costs to be developed; works expected to commence late summer 2025; complete late summer 2026.

Bebside to Blyth Cycling and Walking Corridor – OBC submitted to secure funding but there is still work to do and we are a long way off design and costs, etc, and we need to consider the Blyth Relief Road. Noted that comms are important as it will be perceived to cause a lot of disruption. AF – have we got a definitive date of when the railway station will open? RS – no date but I can share the article from the Chronicle which gives an update on the 6 stations from the Northumberland Line Team and the target continues to be opening before Xmas of the first services/stations including Newsham.










| 7 | TD & FHSF Performance return (for approval) – LB Capital budgets and expenditure shared; we will have spent approx. half by the end of the year; some spend has been pushed back to 2027, ie: Bebside to Blyth Cycling and Walking Corridor; we need sanction from Board to submit the figures but the figures are draft as they need to be agreed by Corporate Finance first. Top 4 Key risks/mitigations include the hotel for which we have asked for an extension regarding the spend date as we need to go out to the market again. | 10 | Energising Blyth Wayfinding Strategy - MMa This is a strategy and as such hasn't been costed in detail. The presentation covered - CPP brief; project themes; project outcomes; what is wayfinding; wayfinding benefits; place branding; tourism; public realm; engagement; opportunities; destinations; design strategies; phased approach 1 – 6, character areas; joining the dots; welcome to Blyth; icons, beacons, gaps and gables. WT – Marina Old Gaffer Association who tour the coast, around 50 yachts came in so that can be a destination itself and we should be looking at that to bring people into the town. MMa – that has been flagged as a question to think about as the arrival by boat could be an opportunity for the town. ML – we have been talking about an area of the Dun Cow Quay and putting high fencing around it for use with the tall ships as a security area for example but the community berth could be something to add into that as an important attraction which is in the LTPFT proposal. RS – the hard infrastructure we can deliver the first phase as part of CPP but the strategy is a 10 year strategy and lots of people in this Board have a role in the whole strategy. The project ML refers to is in the pipeline for the LTPFT. | |
