Delay on Rental Reform White Paper

The Government have put a delay on the white paper for the Rental Reform bill until 2022. The white paper was expected to be released this Autumn but has been delayed to allow ministers more time to consult with the lettings sector and to also take into account the National Audit Office's (NAO's) review of regulation of the private rented sector.

Anti-Social behaviour.

A lot of landlords claim to have ASB problems with their own tenants however, some tenants can suffer from ASB from other tenants in the area. If one of your tenants is experiencing ASB problems within their street/area, they can speak to our Community Safety team via the customer services number – 0345 6006400.

CAB Debt Advice
