*Description of Conservation Area in the Rural District of Rothbury*

From the Bridge the boundary runs westwards along the north bank of the River Coquet, then turns north along the western boundary of the County Hotel crossing the B.6341 road and the Pondicherry road to a line at the back of the properties fronting onto the north side of Market Street. The boundary then runs eastwards as far as Thomson's School which it then skirts to the west and north, then running along the north and east side of Addycombe Cottages from which it strikes south-east down to the Cragside road. It then crosses the road and returns south-west along the northern bank of the River, back to the Bridge.

To the west the boundary follows the parish boundary from the river up to the Ovington Road and then skirts as far as the road bridge over the Whittle Burn; from this point it takes in the field immediately to the east of the old Church of England school; it then runs approximately north-easterly along the rear of the properties fronting on to the north side of the main street, stopping just short of Castle View Terrace; it then returns in a south-easterly direction to the riverside.

#### SCHEDULE

##### *Description of Conservation Area in the Rural District of Hexham*

The northern boundary of the Conservation Area runs from the river bank opposite the old Allendale Brewery eastwards along the back of the properties to the north of Peth Head and the Market Place, along the north side of The Church and round the Temperance Hall to the main Hexham Road.

Crossing the road it then takes in The Cottages including The Smithy, round the back of the school, across the road taking in Far Houses and The Rectory together with the cottages adjacent, and the Jubilee Almshouses on the other side of the road.

The boundary then runs south-west to the rear of the properties on the south side of the Market Place and southwards down the Allenheads Road to the southern end of Wentworth Place. Crossing the road at this point it returns northwards, taking in Wentworth Place, then across to the river bank just to the south of the Methodist Chapel. From here it runs south down the river bank, crosses the river to take in Wooley Burnfoot and follows the field boundaries round to Bridge End, skirting Bridge End House and the adjacent cottages. It then crosses the river just to the north and returns northwards along the south bank to a point opposite the Old Brewery.

*Somerset (Footpaths Nos. 2/8 and 2/9 at Coles Quarry, Backwell) Public Path Diversion Order, 1971.*

Notice is hereby given that on the 22nd September 1972, the Secretary of State for the Environment confirmed the above-named Order.

The effect of the Order as confirmed is to stop up and divert Footpath 2/8 at Coles Quarry, Backwell for a distance of approximately 30 yards from its junction with Footpath 2/9 and Footpath 2/9 at Coles Quarry, Backwell from a point approximately 130 yards south-west of its junction with Chelston Combe, for a distance of approximately 380 yards in a generally southerly direction to a new route running easterly, southerly, and then south-westerly to rejoin Footpath 2/9.

*The Stratford-on-Avon Rural District Council Claverdon (S.D.178) No. 1 Public Path Diversion Order, 1972.*
