NOTICE OF DESIGNATION OF CONSERVATION AREA

Extension of Conservation Area at Berwick-upon-Tweed

Notice is hereby given that on 7th August 1970 Northumberland County Council designated the area whereof a brief description is shown in Part II of the Schedule to this notice as a conservation area;

And whereas Berwick-upon-Tweed Borough Council acting in pursuance of their powers thereunder as local planning authority have reviewed the past exercise of functions under these Acts by determining whether any parts or further parts of their area should be conservation areas.

Notice is hereby given in pursuance of section 277 of the Town and Country Planning Act 1971 as substituted by section 1 of the Town and Country Planning Amenities Act 1974 that the Berwick-upon-Tweed Borough Council on 15th December 1988 determined that the area described in Part I of the Schedule to this notice is an area of special architectural or historic interest the character or appearance of which it is desirable to preserve or enhance and have accordingly designated the said area as a conservation area. The effect of the designation of the conservation area may be summarised as follows:

- (a) Where any application for planning permission for development of land in or adjacent to the conservation area is made to the Council and the development would, in the opinion of the Council affect the character or appearance of the conservation area, the application will be subject to the special procedure in section 28 of the Town and Country Planing Act 1971, as amended.
- (b) Anyone wishing to demolish a building or a part of a building situate within the conservation area must first apply for consent to demolition to the local planning authority. This is not taken to be included in a planning permission for redevelopment of the site unless, in granting the planning permission, the authority states that it includes consent to demolish the building. Some buildings may be exempt from this requirement.
- (c) Anyone wishing to cut down, top, lop or uproot a tree situate within the conservation area must give six weeks prior notice of his intention to the local planning authority.

A map of the conservation area now designated showing also the conservation area formerly designated may be inspected free of charge during normal office hours at the office of the Borough Planning Officer at the address below.

And notice is hereby further given that the areas described in Parts I and II of the Schedule to this notice shall be cited together as the Berwick-upon-Tweed Conservation Area.

Part I Area now designated

All that area at Berwick-upon-Tweed in the Borough of Berwickupon-Tweed within the boundary hereafter described, namely: Commencing at a point on the northern bank of the River Tweed some 120 metres north-westerly of the Royal Border Bridge, thence north-easterly across Tommy the Millers Field and Coronation (Gallow Knowe) Park to the junction of the A6105 and A1167 roads and south-easterly along the A1167 road over the railway line to the junction with Northumberland Avenue, thence northerly along the boundary of the railway line with Warkworth Terrace to a point some 15 metres north of the highway to Percy Terrace, thence easterly along the course of the Spades Mire to the High Water mark at Fisherman's Haven and south-easterly and southerly following the High Water mark to a point on Berwick Pier some 192 metres south of Pier House, thence northerly along the pier to a point some 31 metres south of Pier House, thence westerly along the High Water mark and Pier Road to Fisher's Fort thence south-westerly following the town walls to the Saluting Battery some 66 metres west of Coxons Tower thence westerly and north-westerly along the High Water mark of the River Tweed estuary which is contiguous in turn with the Quayside, the Town Walls and the New Road, to a point of commencement aforesaid.
