

## NOTTINGHAMSHIRE COUNTY COUNCIL

Order 1978

AND

*The Nottinghamshire County Council*  
(Noel Street, Nottingham) (Experimental One Way Traffic)  
Order 1978

The Nottinghamshire County Council has made two Orders under Section 9 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be:

1. (a) To close Rawson Street, Nottingham, to all motor vehicles from its junction with Gladstone Street to a point 27 metres north of the junction.
- (b) To close Gladstone Street to all motor vehicles from its junction with Fisher Street to a point 10 metres east of the junction.
- (c) To close Beaconsfield Street to all motor vehicles from a point 13 metres east of the junction with Fisher Street to a point 18 metres east of the junction.
2. To make Noel Street, Nottingham, a one-way street (southbound only) between Beaconsfield Street and Berridge Road Central.

The Orders and relevant documents may be inspected during office hours at my office or at the office of the City Secretary and Solicitor, The Guildhall, Nottingham.

The Orders will be in force for an experimental period of six months.

Any person wishing to question the validity of the Order or any of the provisions contained in it on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1967 as amended or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order may, not later than 3rd March 1978 apply to the

The Orders come into operation on 22nd January 1978. High Court for this purpose.

## NOTTINGHAMSHIRE COUNTY COUNCIL

(Nuthall Road/Melbourne Road and Bar Lane,  
Nottingham) (Prohibition of Waiting) Order 1978

Notice is hereby given that Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1967 as amended prohibiting waiting at any time by vehicles in any of the lengths of road specified in the Schedule to this Notice.

Exemptions will be provided for persons to board or alight from vehicles, goods to be loaded or unloaded from vehicles, vehicles to be used for building operations, removing obstructions, maintaining, improving and reconstructing of roads, the laying, alteration or repair of sewers main pipes or apparatus for gas, water or electrical supplies or of telegraphic lines, vehicles used by statutory undertakers. The usual exemptions will be provided for disabled persons' vehicles.

A copy of the proposed Order and relevant documents may be inspected at my office or at the office of the Secretary and Solicitor, Nottingham City Council, The Guildhall, Nottingham.

Objections (stating grounds) must be received by me by 10th February 1978.

1. Nuthall Road, the south-west side from a point 60 metres south-east of its junction with Melbourne Road to a point 15 metres north-west of that junction.

2. Nuthall Road, the north-east side from a point 37 metres south-east of its junction with Bar Lane to a point 50 metres north-west of that junction.
3. Bar Lane, the south-east side from its junction with Nuthall Road to a point 53 metres north-east of that junction.
4. Bar Lane, the north-west side from its junction with Nuthall Road to a point 23 metres north-east of that junction.
5. Melbourne Road, the west side from its junction with Nuthall Road to a point 60 metres south of that junction.

## TOWN AND COUNTRY PLANNING ACTS 1971-74

Notice is hereby given that in accordance with Section 277 (7) of the above Act the Borough of Blyth Valley, in pursuance of their powers under Section 277 (1) of that Act, have designated the under-mentioned area of the Borough as a Conservation Area:

"The buildings and most of their curtilages within the area bounded by and including:

On the north side: The site of the former Sunday School, Hartwood House, Fontana, Dene View, War Memorial Homes, Holywell Garage, Milbourne Arms, 6 Holywell Close, North Farm and allotments.

On the east side: North Farm and allotment, Strother Farm, Ordnance Survey plot 8447, that part of Ordnance Survey plot 0055 to the south-west of a line adjoining the eastern most points of O.S. plots 8447 and 8838, O.S. plots, 8838, 8431 and 8020.

On the south side: Bank Top Farm, O.S. plot numbers 6928, 6123 and 5640.

On the west side: Ordnance Survey plot number 5640, land to the east of a line parallel to the party wall of numbers 51 and 53 Wallridge Drive beginning at a point on the footpath at the midpoint of the frontage of 51 Wallridge Drive and extending to a point where it intersects with the northern boundary of O.S. plot number 5640, the site of the former Sunday School."

A plan showing this area can be inspected during normal office hours at the Planning Office, Council Offices, Seaton Delaval.

The effect of the designation of this area as a Conservation Area will be that no person may, without the written consent of the Council, demolish any building or cut down, top, lop, uproot or wilfully damage or destroy any tree within the Conservation Area. Offences against these provisions may result in heavy fines.

The Council will also give special attention to the desirability of preserving or enhancing the character or appearance of the designated area, both in works initiated by the Council and in making decisions on applications for planning permission within or materially affecting the designated area.
