The Conservation Area is bounded on the west by the River Wansbeck, from the footbridge adjacent to Wansbeck House, south to Oldgate Bridge. From there the boundary follows the properties to the south of Oldgate and Bridge Street, and thence southwest along the bank of the Wansbeck to the Weir, crossing the river, and including the Court House and Castle Square. It then follows the A.1 bridge, behind St. George's Church, and follows the rear of the properties north of Bridge Street, and east of Newgate Street, including the Church of St. James and its precinct to Bow Villa in the north, crosses the A.1 and follows the western end of the properties on North Place and Buller's Green southwards behind Wansbeck Place and follows the footpath to the footbridge. path to the footbridge.

The line then runs south to cross the River Mole and continues southwards passing to the east of Brockham Court and behind properties fronting Wheelers Lane.
